Application by Gatwick Airport Limited for an Order Granting Development Consent for the Gatwick Airport Northern Runway Project

Accompanied Site Inspection itinerary – 7 March 2024

The itinerary for the Accompanied Site Inspection (ASI) can be found at **Annex A** below.

Please note that the Examining Authority's (ExA) inspection of a site is **not** an opportunity to provide any oral representations on the project or discuss evidence. It is an opportunity for the ExA to look at the physical features that can be seen on, or from, the site. Participants may be invited by the ExA to point out specific features of interest.

Attendees

The ASI is to enable the ExA to view the 'airside' aspects of the Proposed Development. Due to the necessary security procedures to enable visitors to go airside, numbers at this visit will be restricted. The ExA proposes that it is accompanied by representatives from the Applicant and one representative from the local authorities. The draft Examination Timetable at Annex D of the ExA's Rule 6 letter includes the provision for a further ASI at a later date should this be required, and Interested Parties were able to suggest locations for any such visits (or unaccompanied ones) by making a submission for Procedural Deadline A.

Joining the site visit

The site inspection will commence at 10:00am at Gatwick Airport. The attendees referred to above are asked to assemble promptly in accordance with the timings set out in the itinerary.

To ensure the smooth running of the ExA's inspection, attendees are requested to provide contact details for the day, notify the Case Team if there are any changes in attendance, and ensure the Planning Inspectorate is made aware of any special access requirements.



Clothing

Attendees are recommended to wear appropriate sturdy footwear and weather appropriate clothing. The Applicant will provide Personal Protective Equipment, if required.

Sites on private land

Access onto private land is at all times by permission of the person controlling it; occupiers and landowners may refuse to allow some persons accompanying the ExA onto their land. Under those circumstances, the ExA will decide whether or not to proceed with that part of the inspection and may ask those refused access to wait outside.

Cancellations

Please note that in the unlikely event that the ASI is cancelled we shall endeavour to contact attendees beforehand.
