1 Introduction

- 1.1.1 This **Book of Reference Schedule of Changes** (Doc Ref. 3.3 v3) has been prepared on behalf of Gatwick Airport Limited (GAL).
- 1.1.2 It presents a consolidated list of all amendments to version 3 of the **Book of Reference** which was submitted to the Examination Authority on 12 March 2024 [[REP1-009](#), [REP1-010](#), [REP1-011](#) & [REP1-012](#)]. Subsequent Schedules of Changes will be submitted if further changes to the Book of Reference are necessary.
- 1.1.3 As this **Book of Reference Schedule of Changes** (Doc Ref. 3.3 v3) is part of the application documentation, it should be read in conjunction with:

2 Book of Reference Schedule of Changes

- 2.1.1 This Schedule of Changes to the Book of Reference (Doc Ref. 3.3 v3) is a supporting document to the Book of Reference Clean and Tracked versions (Doc Ref. 3.3 v4) and presents a consolidated list of all amendments to version 3 of the Book of Reference which was submitted to the Examination Authority on 12 March 2024 [[REP1-009](#), [REP1-010](#), [REP1-011](#) & [REP1-012](#)]. The Tracked Version of the Book of Reference (Doc Ref. 3.3 v4) highlights the updates to land interest information since previous submission in March 2023 of Book of Reference (Doc Ref. 3.3 Version 3.0) as follows:
- those entries struck through and highlighted in **red** have been removed;
 - those entries highlighted in **green** have been added; and
 - those entries highlighted **orange** have an updated name, address, or qualifier.
- 2.1.2 The changes have been identified through:
- HMLR Refresh;
 - Companies House Registered Name and Address Checks;
 - Company and Organisation desktop research for Name and Address Checks;
 - The applicant supplied data and information including updated tenancy schedules and concession agreements;
 - National Highways updates through consultation and data supply
 - Ongoing reviews of location of interests and rights; and
 - Incoming correspondence including PINS notification, Land Interest Questionnaires,

Confirmation Schedules, Undeliverable Mail and Ad hoc communication regarding changes in circumstances.

2.1.3 In updating the Book of Reference it was identified that a number of rows had been included in duplicate through an exporting error which affected a very limited number of plots. These duplicate rows have been removed from the Book of Reference and are shown as a change in this Schedule of Changes as "removed duplicate interest". This is not a change to the land interests in the plot but the correction of a clerical error.
