1 Introduction

- 1.1.1 This **Land Plans Schedule of Changes** (Doc Ref. 4.2) has been prepared on behalf of Gatwick Airport Limited (GAL).

2 Land Plans Schedule of Changes

- 2.1.1 This Schedule of Changes to Land Plans (Doc Ref. 4.2) is a supporting document to the Land Plans (Doc. Ref. 4.2 v3) and presents a consolidated list of all amendments to version 3 of the Land Plans which was submitted to the Examination Authority on 24 August 2023 [AS-015].
- 2.1.2 The changes have been identified through National Highways updates through consultation and data supply
