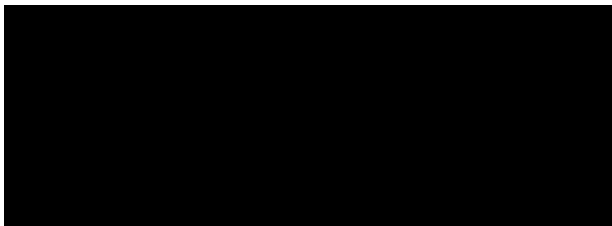

I applied to speak on 30th July but it would not accept my email address. I wrote but have not heard back?

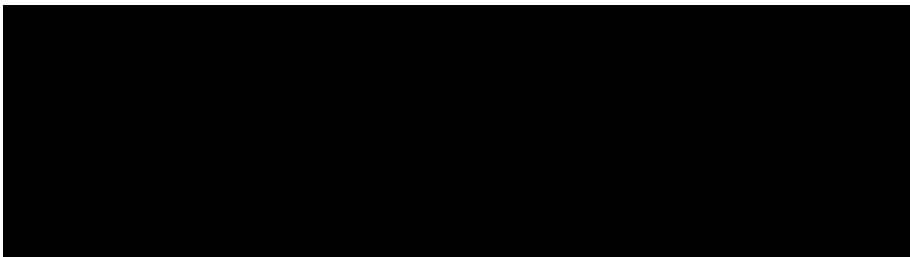
