Application for a Development Consent Order by Gatwick Airport Limited for the Gatwick Airport Northern Runway Project (Ref. TR020005) – Deadline 7 Submission

As set out in its Rule 8 letter [PD-011], the Examining Authority (ExA) has requested the following information of relevance to the Applicant to be submitted at Deadline 7:

## Responses to ExQ2

The ExA published its second set of Written Questions (ExQ2) on Monday 1 July 2024 [PD-021] and set a deadline of Deadline 7 in the Examination Timetable for responses to those questions. #### **Land Rights Tracker**

The Applicant has enclosed an updated version of the Land Rights Tracker (Doc Ref. 8.6 v3) and Land Rights Tracker – Appendix A – Schedule of Changes (Doc Ref. 8.6 v3) to reflect the most recent position based on discussions.

#### **Updated Navigation Document**

The Applicant has submitted an updated version of the **Navigation Document** (Doc Ref. 1.3 v14) as part of the submission.

### Any further information requested by the ExA under Rule 17

The ExA issued a Procedural Decision and a Request for Further Information under Rule 17 on 9 May 2024 [PD-018] in relation to the future baseline. In response, the Applicant produced and submitted its **Response to Rule 17 – Future Baseline Sensitivity Analysis** [REP5-081] and acknowledged at paragraph 5.3.1 that further work was required to understand the impacts of the York Aviation scenarios in the context of specific ecological receptors. The Applicant has now completed this analysis and provided the additional commentary as an update to the **Response to Rule 17 – Future Baseline Sensitivity Analysis** (Doc Ref. 10.40 v2).

This concludes that for non-HRA receptors there would be no material change to the conclusions of **ES Chapter 9: Ecology and Nature Conservation** [APP-034]. On a precautionary basis, for HRA receptors, the changes in AADT associated with the York Aviation scenarios were subject to additional assessment. This determined that the conclusion of the HRAR of no adverse effects on integrity would not change in the York Aviation scenarios.

The Applicant is mindful of the volume of information already submitted into the examination and has sought to limit the duplication of submissions it has already made on certain subjects. As such, the Applicant has not responded to every submission or point made; instead, it has responded by exception where the submission raises a new matter and/or where the Applicant considers such a response may be helpful to the ExA. Silence on an issue, therefore, should not be interpreted as agreement – but instead a recognition of the approach taken by the Applicant in this document.

### **Third Change Application**

The Applicant submitted notification of a proposed change to the application (the Third Change Application Notification) on 5 July 2024, comprising a **Covering Letter** [AS-152] and **Third Notification of Proposed Project Change Report** [AS-153].

As a result of ongoing engagement between GAL and HICP on the Project proposals, the Applicant has put forward a further change at the request of HICP.

Project Change 5 relates to a minor extension to the Order Limits to incorporate additional land (comprising 0.175ha in size) at the Holiday Inn to facilitate the construction of a temporary access point, a temporary bus parking layby, temporary traffic management measures and associated drainage provisions.
