1 Introduction

Purpose of this document

- 1.1.1 This document provides a guide to the Application for a Development Consent Order ("DCO") for the Gatwick Airport Northern Runway Project (the "Project"). The Application is made by Gatwick Airport Limited (the "Applicant") to the Secretary of State pursuant to the Planning Act 2008.
- 1.1.2 The Project proposes alterations to the existing northern runway at London Gatwick Airport (Gatwick) which, along with lifting the current restrictions on its use, would enable dual runway operations. Together with the alterations to the northern runway, the Project would include the development of a range of infrastructure and facilities to allow increased airport passenger numbers and aircraft operations.
- 1.1.3 The Project includes amendments to the existing northern runway and corresponding enhancements to the taxiway system and parking stands to accommodate an increase in aircraft movements. Other elements of the Project would enable the increased airfield capacity to be accessed by passengers through additional processing capability and improved airport access. Land is proposed to be used to mitigate environmental effects (for example, for habitat creation, flood compensation or provision of recreational routes and public open space).
- 1.1.4 This Guide aims to help the Examining Authority and Interested Parties understand the Application by signposting to the documents that make up the Application. It will be updated iteratively following the submission of the Application, both to capture the latest version of updated documents and to record new documents submitted as part of the Examination.
- 1.1.5 This Guide makes reference to the below legislation and guidance which has shaped the content and form of the Application documents:
 - Planning Act 2008 (as amended);
 - The Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009;
 - The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017;
 - Planning Inspectorate's Advice Note Six: Preparation and submission of application documents (Version 11).

Application Books

- 1.1.6 Due to the size and scale of the Application, the documents and plans have been grouped into 'Books' corresponding with the Planning Inspectorate's ("PINS") Advice Note Six: Preparation and submission of application documents (Version 11).
- 1.1.7 The categories of Books are set out in Table 1 and the Application comprises seven Books. Following submission, an additional Book (Book 8) will be added which will contain any new documents submitted after Acceptance or during the Examination.

Book 1: Application Form	Book 1 provides the 'front' documents of the Application, including the Covering Letter (incl. the Section 55 Checklist) (Doc Ref. 1.1), the completed Application Form (Doc Ref. 1.2), this Navigation Document (Doc Ref. 1.3), the Project Glossary (Doc Ref. 1.4) and the Electronic Application Index (Doc Ref. 1.5).
Book 2: Draft Development Consent Order	Book 2 contains the draft Statutory Instrument which contains the legal powers that the Applicant is seeking to enable the construction, operation and maintenance of the Project should consent be granted. This Book comprises the draft DCO (Doc Ref. 2.1), supported by an Explanatory Memorandum (Doc Ref. 2.2) and DCO Verification Report (Doc Ref. 2.3).
Book 3: Compulsory Acquisition Information	Book 3 sets out the land to be acquired or used to construct and operate the Project, alongside evidence to justify the legal powers sought for compulsory acquisition as well as information on how the Project is to be funded. This Book comprises the Funding Statement (Doc Ref. 3.1), Statement of Reasons (Doc Ref. 3.2) and Book of Reference (Doc Ref. 3.3).
Book 4: Plans / Drawings / Sections	Book 4 contains the plans which show where and how the Applicant proposes to deliver the Project. This includes a Location Plan (Doc Ref. 4.1) showing the Order Limits, Land Plans (Doc Ref. 4.2), Crown Land Plan (Doc Ref. 4.3), Works Plans (Doc Ref. 4.4), Rights of Way and Access Plans (Doc Ref. 4.5), Special Category Land Plans (Doc Ref. 4.11) and other plans to define and illustrate the Project (Doc Refs. 4.6 – 4.9).
Book 5: Environmental Impact Assessment and Habitat Regulations Information	Book 5 forms the Environmental Statement and contains the Environmental Impact Assessment ("EIA") information, providing an assessment of the likely significant effects (both positive and negative) of the Project on the environment and a description of mitigation measures proposed to reduce any negative effects. The Environmental Statement also provides general information on the Proposed Development including its context, a full description of the Proposed Development and its construction, the main alternatives considered, the consultation process that was part of the EIA and any relevant technical information that has been used to assess the likely significant effects of the Proposed Development.
	The Environmental Statement in Book 5 is organised into three volumes: ES Volume 1 (Doc Ref. 5.1) contains the ES Chapters; ES Volume 2 (Doc Ref. 5.2) contains the ES Figures; ES Volume 3 (Doc Ref. 5.3) contains the ES Appendices; alongside the ES Non-Technical Summary (Doc Ref. 5.4).
Book 6: Consultation and Engagement	Book 6 sets out the methodology and outcomes of the pre-application consultation undertaken on the Project and explains how responses to the consultations have been taken into account. This Book includes the Consultation Report (Doc Ref. 6.1) and the Consultation Report



	Appendices (Doc Ref. 6.2).
Book 7: Reports / Statements	Book 7 contains additional documents that support the Application. This Book includes the Planning Statement (Doc Ref. 7.1), Needs Case (Doc Ref. 7.2), Design and Access Statement (Doc Ref. 7.3), Transport Assessment (Doc Refs. 7.4.1 – 7.4.6), List of Other Consents and Licences (Doc Ref. 7.5) and Statement of Statutory Nuisance (Doc Ref. 7.6).
Book 8: Documents submitted during the Pre-Examination Period	Book 8 contains additional documents that support the Application submitted during the Pre-Examination Period.
Book 9: Change Application 01	Book 9 contains documents submitted related to Change Application 01.
Book 10: Documents submitted during the Examination Period	Book 10 contains additional documents that support the Application submitted during the Examination Period.

Document Schedule

- 1.1.8 Appendix A of this Guide provides a comprehensive document schedule which is duplicated in the **Electronic Application Index** [APP-005]. This is a live part of this Guide and will be updated during the subsequent stages of the application process.
- 1.1.9 A copy of the Application documents will be made available on the PINS website. Requests for printing and distribution of hard copies can be made to the Project Team by contacting community@gatwickairport.com and will be subject to a reasonable charge.

Document Reference Numbering

- 1.1.10 Documents are numbered in sequence within the respective Books, with the Book number being the first digit of a document number. This is followed, where relevant, by the document number and the Chapter number if these are standalone documents. For example, documents within Book 1: Application Form are numbered 1.1, 1.2, 1.3, etc.
- 1.1.11 The Environmental Statement ("ES") is contained in Book 5, comprising three Volumes and one non-technical summary, organised into 5.1, 5.2, 5.3 and 5.4. Within the Volumes, the ES has its own unique numbering system for the Figures and Appendices, corresponding to the relevant section of the ES Chapter. For example, the Forecast Data Book is discussed in Section 4.3 of ES Chapter 4 and therefore has a unique ES reference of Appendix 4.3.1 in **ES Volume 3** (Doc Ref. 5.3).
- 1.1.12 When revised documents are submitted in future during the Examination, these will be given a revision number alongside the document number.
