1 Purpose of Document

- 1.1.1 An **Environmental Statement** ([APP-026] to [APP-217]) ("**ES**") was submitted to the Planning Inspectorate on 6 July 2023 as part of the Development Consent Order application for the Gatwick Airport Northern Runway Project (the "**Project**").
- 1.1.2 Since the submission of the ES in July 2023, there have been updates to a number of ES chapters, figures and appendices to reflect Project changes, to provide clarificatory information or to correct errata. A number of additional submissions have also provided clarificatory and/or supplementary information (often in response to submissions made by Interested Parties). This has comprised the following:
 - the **First Change Application** submitted on 13 February 2024 ([AS-139]) to [AS-141]), the **Second Change Application** submitted on 26 June 2024 ([REP6-072]) to [REP6-077]), and the **Third Change Application** submitted on 15 July 2024 [REP7-097] and [REP8-102]. Each time a change application has been submitted, the Applicant has included in the application report a list of the documents that have been or are to be updated as a result of the change, meaning that the application documents (including the ES) have always remained up to date;
 - an ES Addendum Updated Central Case Aircraft Fleet Report [REP4-004] was also submitted into the Examination at Deadline 4 relating to the Updated Central Case representing what the Applicant considers to be the most likely rate of fleet transition; and
 - other documents that have been submitted during the course of the Examination (such as technical notes, sensitivity analyses and similar) which contain supplementary information which the Secretary of State would take into account when considering the environmental effects of the Project.
- 1.1.3 The ES submitted in July 2023, together with the documents referred to in paragraph 1.1.2 comprise the ES for the Project. Tables 1.1 to 1.5 below contain details of each ES document, including information about the latest versions of each, and details of any other documents which are relevant to that part of the ES.
- 1.1.4 Additionally, over the course of the Examination, a number of other submissions have been made by the Applicant, often in response to submissions from Interested Parties or at the request of the Examining Authority ("ExA"), including the Applicant's responses to the ExA's written questions. These submissions



have often been provided to assist with the interpretation of information contained in the ES. These documents are complementary to, and informative of, the information in the ES. These documents are cross referred to in Tables 1.1 to 1.5 where they assist in the interpretation of the relevant part of the ES. The Applicant's Responses to the ExA's Written Questions (ExQ1) (arranged by topic) [REP3-083] to [REP3-105], the Applicant's Responses to the ExA's Further Written Questions (ExQ2) (arranged by topic) [REP7-078] to [REP7-093] and the Applicant's responses to the ExA's Action Points arising from the hearings during the Examination ([AS-162], [AS-163], [REP1-062] to [REP1-066], [REP4-036] to [REP4-038], [REP6-084] to [REP6-089], [REP7-071] and [REP8-111] to [REP8-113]) have not expressly been referred to in the tables below, however, they are also relevant to the environmental topics as they set out the Applicant's responses to matters raised by the ExA (and, where applicable, other interested parties) during the Examination, many of which relate to, and assist in the interpretation of, the ES.

- 1.1.5 At Issue Specific Hearing 8, the ExA asked the Applicant to provide, at Deadline 9, a consolidated ES incorporating all the various amendments to the ES throughout the Examination (see Agenda Item 10 in [EV17-001] and paragraph 3.2.1 of [REP6-083]). The Applicant also refers to the ExA's Further Written Question (ExQ) GEN2.11 [PD-021] which reiterates the ExA's request. This document is intended to serve that purpose. Column 3 in each of Tables 1.1 to 1.5 comprise this "consolidated" ES. In the Response to the Examining Authority's Written Questions (ExQ2) General and Cross-Topic (GEN2.11) [REP7-083], the Applicant confirmed that this document would be submitted in draft at Deadline 8, rather than Deadline 9, to allow all parties and the ExA sufficient time to comment on it. The document has subsequently been updated and the final version is submitted at Deadline 10.
- 1.1.6 As noted in the response to GEN2.11, The Applicant considers that the ES has been kept up to date during the course of the Examination. This has been achieved through a combination of correcting errata identified during the course of the examination, providing additional clarification information in response to written questions/submissions and/or updates to relevant underlying information where necessary, as noted above. This signposting document captures all of this information and explains how it interfaces with the original ES chapters.
- 1.1.7 This document provides a list of all documentation associated with the ES and other associated documentation, and the appropriate document references from the Project's Examination Library. Links to each document can be found within the Examination Library on the Northern Runway Project page of the PINS



website. This document will also be listed as a document to be certified by the Secretary of State in Schedule 14 to the Draft Development Consent Order.
