**NOTIFICATION OF ACCOMPANIED MARINE SITE VISIT RULE 16 EXAMINATION
PROCEDURE RULES**

I am writing to you as lead member of the Panel of Examining Inspectors to provide you with notice of the rearranged accompanied marine site visit to be carried out in respect of the Able Marine Energy Park proposal. As you may be aware, the visit scheduled for Wednesday 24 October was unfortunately cancelled due to adverse weather conditions.

The visit will now be held on Wednesday 14 November 2012 and the purpose remains as previously notified i.e. to allow the Panel to see particular locations to which there has been reference in evidence so that the Panel has a better understanding of these locations, their significance and their context.

Registration for the visit will take place between 08.15 and 08.30 at the Humber Royal Hotel, Littlecoates Road, Grimsby, DN34 4LX. The visit will begin at 08.30 with transport to the launch point provided.

Capacity for this visit is extremely restricted. Those parties wishing to attend will be restricted to one place, and it may be necessary to refuse even one place if the visit is over-subscribed. The Panel can confirm that it is aware of the points of interest and issues of concern raised by Interested Parties in both written representations and the hearings previously held. In light of this we would encourage you to consider carefully whether you need to attend.

I would remind you that the site visits are not to be considered as 'mobile hearings' and the Panel will not be taking any evidence during the site visits. You will be permitted to identify points of fact e.g. landmarks and to answer questions of clarification asked by the Panel.
