DRAFT EPS MITIGATION LICENCE APPLICATION STATUS: RESUBMISSION

LEGISLATION: CONSERVATION OF HABITATS AND SPECIES REGULATIONS 2010 (as

SITE: ABLE MARINE ENERGY PARK, ROSPER ROAD, KILLINGHAM, LINCOLNSHIRE

EUROPEAN PROTECTED SPECIES: GREAT CRESTED NEWT (*Triturus cristatus*)

Thank you for your draft great crested newt mitigation licence resubmission in association with the above site, which was received in this office on the 21st September 2012 and I apologise for the delay in issuing our response. This application relates to a Nationally Significant Infrastructure Project which Natural England has agreed to review to help ensure the proposals meet protected species licensing requirements. As you will be aware, no final licensing decisions can be made, or a licence issued, unless the development obtains all necessary consents in order to proceed, with any conditions relevant to wildlife discharged. Accordingly we cannot issue a licence unless the Secretary of State grants the Development Consent Order (DCO) in relation to these proposals.

Following our assessment of the resubmitted documents, I can now confirm that, on the basis of the species information and proposals provided, Natural England is satisfied that no outstanding issues remain which would prevent the licence being granted in respect of this application if the following advice is followed.

Natural England considers that the Purpose and No Satisfactory Alternative (NSA) tests would be met should the application be formally submitted using the same information and the development is successful in achieving all necessary consents. However, in relation to the Favourable Conservation Status Test (FCS), please take note of the following:

Method Statement

Favourable Conservation Status Test (FCS)

We agree that the principles of mitigation proposed allow us to grant a letter of comfort for this scheme. In the event the DCO is granted and you wish to obtain a licence for the proposed works, the following issues must be addressed within your formal submission:

- the timetable in E6b only includes 5 yrs of population monitoring at present. However, 6 yrs of monitoring is required and this is what has been proposed in section E5.2. Consequently, the E6b timetable will need to be amended upon formal submission to include a further year of monitoring in 2020.
- In addition, the Management Plan ('Habitat Creation and Management Proposals') proposes a new fence to be erected along the northern boundary of the receptor site to restrict public access. This fence-line must be shown on map E5.1 as it is intended to prevent excessive disturbance and damage to the created habitats.

Natural England would normally request that these issues be addressed before the granting of a 'letter of comfort' in relation to an NSIP proposal. However, on this occasion, to avoid further delays, we are content that they can be resolved at the formal application stage, should the DCO be granted. Please be advised that Natural England will undertake a full reassessment of any formal application received and we will be unable to grant the licence unless these two outstanding issues have been addressed.

General advice and next steps

Should the DCO be granted you are in a position to formally submit your newt application.

Please be mindful that we will only issue a licence within 12 weeks of the first licensable activities. If changes are necessary, other than those already detailed above, then these should be outlined in a covering letter and must be reflected in the formal submission of the licence application. These changes must be agreed by Natural England before a licence can be issued. Please be aware that if changes are made to proposals or timings which do not enable us to meet any of the three licensing tests, we will issue correspondence outlining why the proposals are not acceptable and what further information is required. These issues will need to be addressed before any licence can be issued.

As stated in the above guidance note, I should also be grateful if an open dialogue can be maintained with yourselves regarding the progression of the DCO application so that, should the Order be granted, we will be in a position to assess the final submission of the application in a timely fashion and avoid any unnecessary delay in issuing the licence.
