The main reason I see for Tilbury 2 is not one of expansion, it is one of change to be able to compete with the London Gateway. Who are taking business away from Tilbury Docks.

My concerns are the cmat plant, with noise and dust. Could this not be located in the existing port.

Pollution in general

The new jetty which is already being sold to P&O with the main feature of not having to use locks to access the ports which in turn will allow the trucks to be on the road by 0500 hours, straight onto the new road right past our houses. P&O want to increase the number of vehicles by thousands.

The link road would be used far greater than reported and if linked to the new crossing it will be a nightmare for residents, in my opinion the link road should not even be considered which will take away a lot of the traffic and put it where it was originally intended. Current thinking is purely for the benefit of the port.

The rail corridor should be looked at with the possibility of diverting all goods trains onto this track so as to at least take some noise way from residents.

The sound barriers should be more than just dirt embankments as I doubt these will be sufficient, especially considering the amount of vehicles could way more than reported and that was already at 3000 per day. Offer of soundproofing for houses etc, is all well and good but what of when outside. Could sound damping fencing be put on the back of the properties at 8ft high?

I moved into this bungalow as a retirement plan and because my wife suffers from a number of illnesses, including depression and fiber myalgia and I am really concerned over her well being stuck at home all day
