I'm writing to notify you that RWE wishes to attend and make oral submissions at the Compulsory Acquisition Hearing in April.

RWE also wishes to attend the Issues Specific Hearing as an observer, it does not propose to make oral submissions at this hearing.

RWE would also like to attend the Accompanied Site Visit on 16<sup>th</sup> April when the Panel visits locations in and near to the proposed development. On this visit RWE would like the Panel to view the proposed TEC site to better understand the rights that it retains over the Tilbury 2 site for the purposes of its development (access and services) Additionally, it would also like the Panel to view the jetty infrastructure to understand how RWE's existing infrastructure relates to the jetty and where potential new cooling water intake infrastructure will be located in relation to the jetty. Access to RWE's site is restricted and PPE will be required for the visit. The jetty and RWE's infrastructure can be viewed from the River footpath although a member of RWE will need to be present to explain where RWE's infrastructure is located and where any new infrastructure would be located.
