Final section 106 agreement	PoTLL/T2/EX/232	This has been sent to you this evening under separate cover by our legal adviser Nicholas Mansell. Following Deadline 6, further discussions with Thurrock Council have required minor tweaks to the Agreement at Deadline 7 to ensure consistency between various parts of the document, including the removal of Appendix 5 which was not mentioned in the document itself. This version is the final form and the Applicant understands that Thurrock Council will be writing to the Examining Authority to confirm this.

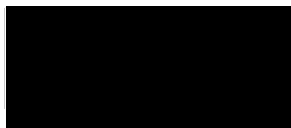

Explanatory note of section 106 Agreement	PoTLL/T2/EX/233	This has been produced as the Applicant is aware that the section 106 agreement has not been discussed in detail in Examination submissions. This document simply explains how the section 106 agreement has developed and how the provisions meet the relevant policy and statutory tests.
DCO revision 7 - Clean	PoTLL/T2/EX/234	This version of the DCO (and its associated documents) reflects agreed protective provisions with Highways England and Thurrock Council, and modified protective provisions for RWE.

DCO revision 7 – Tracked Changes against Application version	PoTLL/T2/EX/236	
Explanatory Memorandum – Clean	PoTLL/T2/EX/237	Discussions have also not yet completed with the Environment Agency in respect of the proposed disapplication of the abstraction licensing regime in relation to construction de-watering, but it remains the Applicant's position that such activities should be able to be included within the ambit of the Agency's protective provisions within the DCO.
Explanatory Memorandum – Tracked Changes against Application version	PoTLL/T2/EX/238	Discussions with the Environment Agency will therefore continue with the aim of obtaining its section 150 consent to this disapplication prior to the Secretary of State's determination of the application for the Tilbury2 DCO.
