It has been drawn to our attention that following the submission of version 6 of the DCO at Deadline 7, the Applicant submitted a further version of the DCO (version 7) which was accepted at the discretion of the Examining Authority and not published until after the close of the examination.

The protective provisions in the version 7 DCO in favour of RWE are unchanged from those in version 6 with the exception of the addition of paragraph 144(2) related to access for abnormal loads. Consequently, the submissions in our earlier letter of 20 December 2018 remain just as relevant to the version 7 DCO as for version 6.

In respect of the provisions added by the Applicant relating to access for abnormal loads, RWE maintains that its suggested provisions at paragraph 138 of its version of the protective provision at Appendix 2 of its Deadline 7 submission are to be preferred for the reasons explained at paragraph 2.11.4 of its Deadline 7 submission. In particular, the inclusion of a reasonable endeavours obligations to facilitate abnormal load access does not preserve RWE's rights as referred to in that submission.
