

I can confirm that the OMSSD project is currently at the Pre-Application stage of the DCO process and an application for Development Consent has not yet been submitted to the Planning Inspectorate. An application is expected to be submitted in Quarter 3, 2021.

As you may be aware, the Applicant (Oikos Storage Ltd) has recently carried out its statutory consultation period. It is understood, from the Applicant's website (https://www.oikos.co.uk/our-development/) that the deadline for consultation responses was 18 May 2021. Please note that the Pre-Application consultation process is entirely led by the Applicant, who are responsible for ensuring that they comply with the legislative requirements surrounding consultation which are set out in the Planning Act 2008. This includes a legal requirement for the Applicant to consult with Statutory Bodies such as the Health and Safety Executive (HSE). Your correspondence provides your comments on the merits of the Proposed Development, which the Applicant sought during its consultation. The Planning Inspectorate would advise you to make these comments directly to the Applicant if you have not already done so. If you are not satisfied that the Applicant is taking your comments into account you should raise this with the Local Authority.

<u>Information about the Planning Inspectorate's remit once an Application is submitted</u>

When an application is formally submitted to the Planning Inspectorate for Examination, an assessment is made on whether it is of a satisfactory standard to proceed to an Examination. One key element of this assessment is to check whether the Applicant has fulfilled its statutory consultation duties. In order to help make an informed decision on this matter the Planning Inspectorate writes to all relevant Local Authorities for their views on the adequacy of the consultation. The Applicant is also statutorily required to demonstrate in its submitted application where they have shown regard to responses received during their period of statutory consultation.

If the application is subsequently accepted for Examination, parties are able to register as an Interested Party and make Relevant Representations for the appointed Examining Authority to consider. Please read the Planning Inspectorate's advice note on How to Register to participate in an Examination (https://infrastructure.planninginspectorate.gov.uk/wp-content/uploads/2013/04/Advice-note-8-2v3.pdf) for further information.

The appointed Examining Authority will make an initial assessment of the issues arising from the submitted application as well as from the Relevant Representations received, which will inform their Examination of the proposed development.
