


2. Updated Statements of Common Ground

2.1. The ExB requested eight Statements of Common Ground; these have all either been signed (2) or agreed with the other party (6). Annex A to this letter sets out the status of each one and indicates which Statements of Common Ground have been submitted at Deadline 3. ABP (Commercial) has not been in touch since the Preliminary Meeting as regards a Statement of Common Ground, and its submission at Deadline 2 (REP2-002) indicated that it is content not to enter into a Statement of Common Ground with the Applicant.

3. Other submissions

- 3.1. As requested by the ExB, Water Framework Directive report comparison document which compares the application version (APP-070) and the Deadline 1 version (REP1-004) is provided as document TR030006/D3/4. This document was submitted as an additional submission (REP1-041), but is being submitted again at this deadline for completeness.
- 3.2. As requested by the ExB, Habitat Regulations Assessment report comparison document which compares the application version (APP-067, APP-068) and the Deadline 1 version (REP1-023) is provided as document TR030006/D3/5. This document compares parts 1 and 2 of the Habitats Regulations Assessment only, as no changes have been made to parts 3 and 4 of the application version of the Habitats Regulations Assessment (APP-069).
- 3.3. Updated Planning Policy Technical Note as document TR030006/D3/6 as was agreed in the Deadline 1 submission of the Statement of Common Ground with North Lincolnshire Council (REP1-022).
