- 1.2.4. Question 5.0.8 – this requested the original sHRA which is submitted as document TR030006/D4/7;
- 1.2.5. Questions 5.0.13 and 5.0.15 – in answering these questions a revised screening matrix document has been submitted as documents TR030003/D4/8 (clean version) and TR030006/D4/8/T (tracked version);
- 1.2.6. Question 6.0.3 - in answering this question a revised version of the WFDa has been submitted as document TR030003/D4/9;
- 1.2.7. Questions 9.0.1 and 9.0.5 – the answers to these questions are provided separately as document TR030006/D4/10;
- 1.2.8. Question 9.0.2 – in answering this question photographs of aviation warning light have been submitted as document TR030006/D4/11;
- 1.2.9. Question 9.0.8 – this asked about the presence of night-time crane aviation warning lights in the Applicant’s night-time photomontages; Figure 7 Rev A and Figure 8b Rev A have been amended to include additional information and are submitted as TR030006/D4/12;
- 1.2.10. Question 11.0.1 – this queried the date of the Marine Written Scheme of Investigation referenced within the Statement of Common Ground with North Lincolnshire Council; a corrected version of the same is submitted as document TR030006/D4/SOCG/NLC;
- 1.2.11. Question 11.0.2 – this requested clarification on the Written Scheme of Investigation Figures; the WSI with Figures is submitted as document TR030006/D4/13;
- 1.2.12. Question 13.0.1 – in answering this question, supporting documents relating to cumulative assessment have been submitted as document TR030006/D4/14.

4. Comments on any other information/submissions received

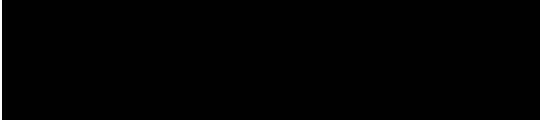


4.1. The Applicant has responded to the MMO's D3 submission (REP3-019) and this has been submitted as document TR030006/D4/16.
