Further to our earlier discussion, I am now writing formally on behalf of my client Associated British Ports, to give advance notice of our intention to ask the Secretary of State for a scoping opinion pursuant to Regulation 10 (1) of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the "EIA" Regulations) in relation to the above proposed development.

It follows from the above and I would, therefore, be grateful if in addition you would take this as formal notice pursuant to regulation 8(1)(b) of the EIA Regulations, that our application for a Development Consent Order will be accompanied by an environmental statement.

We anticipate that the scoping request will be submitted to you on, or during the week commencing Monday 6 September 2021. As required, I have attached a GIS shapefile which identifies the land for which the scoping request will be made.
