

1 Introduction

- 1.1 This Guide to the DCO Application has been provided in connection with an application that has been submitted to the Secretary of State for Transport by Associated British Ports ("ABP") under the provisions of section 37 of the Planning Act 2008 ("PA 2008") for a Development Consent Order ("DCO").
- 1.2 ABP is seeking development consent for the construction and operation of the Immingham Eastern Ro-Ro Terminal Development ("IERRT"). This will comprise a new three berth Ro-Ro facility, with hinterland cargo storage, at the Port of Immingham, which is owned and operated by ABP.
- 1.3 This Guide to the DCO Application has been prepared in accordance with regulation 5(2)(q) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 as a document which ABP considers necessary to support the application.

Purpose of the Guide to the DCO Application

- 2.1 This document is being provided to act a guide to the application by Associated British Ports ("ABP") ("the Applicant") for a Development Consent Order ("DCO") for the Immingham Eastern Ro-Ro Terminal ("the Project"). Its purpose is to provide an understanding of the structure of ABP's application and explain what the application documents are.
- 2.2 This document is intended as a live document which will be updated when updates or revisions to existing application documents are made, or when new documents are submitted to the Planning Inspectorate.
- 2.3 It is intended that revised versions of this document will be submitted for each examination deadline, each setting out which application document versions are the most up to date.

Application Document Overview

- 3.1 The reports, drawings and plans that make up ABP's application for development consent have been organised into 10 volumes as listed in Table 1.
- The constituent parts of these ten volumes are set out in more detail in Table 2. Each volume has a unique identifying colour as shown in table 1.

4 IERRT Application Master Document List

- 4.1 The master document list table is set out on the following pages and provides a full list of all the documents submitted to date, indicating either the latest revision (if applicable) or when a new document was submitted.
- 4.2 Save for Statements of Common Ground, any new documents submitted during the examination (except revisions to previously submitted documents that may be updated and resubmitted as and when required) will be Volume 10 documents. The numbering of the documents will follow the sub-categories as noted below:
 - 10.1 Supplemental Environmental or Engineering Information;
 - 10.2 Other Submissions save for those relating to Changes; and

- 10.3 Scheme Changes Documents.
- 4.3 Statements of Common Ground (SoCGs) will be included in Volume 7 documents with numbering from 7.1. The Applicant intends to submit SoCGs with the relevant parties in the lead up to, and during, the examination.
- In addition to listing the Application Documents submitted, Table 2 also identifies where these have been provided in order to comply with relevant legislative requirements. The legislative requirements for DCO applications are principally contained in the 2008 Act, the Infrastructure Planning (Applications: Prescribed Forms and Procedures) Regulations 2009 (APFP Regulations) and the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (The Infrastructure EIA Regulations 2017).
- 4.5 Regulation 5 of the APFP Regulations lists the documents that all DCO applications must include. Regulation 5 includes a category (Reg. 5(2)(q)) described as "any other documents considered necessary to support the application". Similarly, Regulation 5 (Reg. 5(2)(o)) also allows applicants to submit other plans, drawings and sections which are considered necessary to describe the proposals for which development consent is sought. Regulation 6 of the APFP Regulations sets out a number of documents that particular types of DCO application must include.
- The Application submitted for the Project is considered to comply with the statutory requirements of the 2008 Act, the APFP Regulations and the Infrastructure EIA Regulations 2017, and also with the applicable SoS and Planning Inspectorate (PINS) guidance, including PINS Advice Note 6 'Preparation and submission of application documents' (version 11).
