Section 46(1) of the Planning Act 2008 : Duty to Notify Secretary of State of Proposed Application Planning Inspectorate Case Reference: TR030008

Associated British Ports (ABP) is proposing to submit an application under the provisions of section 37 of the Planning Act 2008 (as amended) ("the 2008 Act") for a Development Consent Order ("DCO") for the construction and operation of the Immingham Green Energy Terminal (the "Project"). This letter comprises the formal notification to the Secretary of State for Transport (the "Secretary of State") under section 46(1) of the 2008 Act.

The Planning Inspectorate has acknowledged in its Scoping Opinion (from 10 October 2022) that the Secretary of State was notified by ABP that it intends to submit an environmental statement with its application for development consent further to regulation 8(1)(b) of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 (the "EIA Regulations"). By virtue of Regulation 6(2)(a) of the EIA Regulations the Project is 'EIA development'.

The Project

The Project is identified as a Nationally Significant Infrastructure Project (NSIP) under the 2008 Act and as such its construction requires consent via a DCO. If constructed the Project would consist of a new liquid bulk terminal and associated infrastructure at Immingham, on the eastern side of the Port of Immingham, and would consist of:

On the marine side (the NSIP):

- A jetty, consisting of an approach trestle, approximately 1.1km in length, leading to up to two berths, including loading platforms and berthing and mooring dolphins with link walkways; and
- Topside infrastructure on the jetty for the handling of bulk liquids, including loading arms and pipelines.

On the land side (the Associated Development):

- An access road to the jetty;
- Two operational sites supporting hydrogen production facilities (an East Site and a West Site);
- Pipework, pipelines and utilities (i) between the jetty and the green hydrogen production facility on the East Site and (ii) between the two green hydrogen production facility sites and (iii) between buildings and plant within the production operation facilities;
- Refrigerated ammonia storage tank (on the East Site);

- Hydrogen production units that convert ammonia to produce the green hydrogen (on both East and West Sites);
- Hydrogen liquefiers (on both East and West Sites) to liquify the hydrogen for temporary storage (on the West Site); and
- Loading bays to fill road tankers with liquified hydrogen which would then be distributed to hydrogen filling stations throughout the UK (on the West Site).

Ancillary buildings and works:

- Access from the public highway to the two hydrogen production sites; and
- Temporary construction areas.

Statutory Consultation

ABP will be undertaking Statutory Consultation in accordance with sections 42, 47 and 48 of the 2008 Act for the Project from Monday 9 January 2023 until 23:59 on Monday 20 February 2023, providing a consultation period of 6 weeks.

We confirm that the community consultation is being undertaken in accordance with the Statement of Community Consultation ("the SoCC") prepared by ABP in connection with the Project. ABP has consulted with North East Lincolnshire Council, the relevant local authority within which the development site falls, in relation to the contents of the SoCC and the consultation methodology to be adopted for this Statutory Consultation, as required by section 47(2) of the 2008 Act. In preparing the SoCC, ABP also consulted the neighbouring local authorities of North Lincolnshire Council, Lincolnshire County Council, West Lindsey District Council, East Lindsey District Council, East Riding of Yorkshire Council and Hull City Council to ensure that the Statutory Consultation is genuinely comprehensive and will consult the authorities in accordance with its obligations under sections 42(1)(b) and 43 of the 2008 Act. Alongside these neighbouring local authorities, ABP will also consult with the following local authorities during the process of the Statutory Consultation: South Yorkshire Mayoral Combined Authority and the West Yorkshire Combined Authority in order to ensure consistency with the approach taken on a neighbouring DCO application where ABP was also the Promoter.

A combined section 47 and 48 notice is being published, in accordance with section 47(6) of the Planning

Act and Regulation 4(2) of The Infrastructure Planning (Applications: Prescribed Forms and Procedure)

- Regulations 2009, as follows:

 Two times in successive weeks in two local newspapers, *The Grimsby Telegraph and The Lincolnite*, on Monday 9 January 2023 and Monday 16 January 2023
 - Once in a national newspaper The Times on Monday 9 January 2023
 - Once in *The London Gazette* on Wednesday 11 January 2023
 - Once in the Lloyd's List on Monday 9 January 2023; and
 - Once in the *Fishing News* (fishing trade journal) on Tuesday 10 January 2023 (first in public domain) and Thursday 12 January 2023 (official publication date, when the hard copy is available).

Further consultation arrangements

More details about the Project and the Statutory Consultation, along with all consultation documents, plans and maps will be available online during the period of the Statutory Consultation at the Project website, www.imminghamget.co.uk. The materials on the Project website will be available to view and download free of charge.


