As you know we act on behalf of the Applicant in relation to the application for a development consent order (the "**Application**") for the construction, operation and maintenance of the IGET and its Associated Development (the "**Project**"). The Application was originally submitted on 21 September 2023 and accepted for Examination on 19 October 2023, which has since commenced on 20 February 2024.

This letter has been prepared to accompany the Applicant's submissions to the Examining Authority ("**ExA**") at Deadline 1 (13 March 2024) of the Examination. These submissions are made in accordance with the Examination Timetable set out at Annex A of the Rule 8 Letter dated 28 February 2024 [**PD-007**].

**1 Overview of Deadline 1 Submissions**

- 1.1 Submissions made at Deadline 1 comprise the Applicant's response to actions and requests arising from the Preliminary Meeting and Issue Specific Hearings held on 20 – 22 February 2024; as well as other documents or updated documents either requested by the ExA or which the Applicant wishes to be submitted as part of the Examination.
- 1.2 In relation to the responses to the ExA's First Written Questions (WQ1) [**PD-008**] the Applicant's responses have been compiled into separate files responding to each theme of questions (e.g. the Applicant's responses to Q1.1 "General and Cross-cutting" are submitted as one file, the Applicant's responses to Q1.2 "Principle of Development" are submitted as another file, the Applicant's responses to Q1.3 "Climate Change" are a further file, etc.).
- 1.3 Any updated documents supersede the documents previously submitted by the Applicant. The Guide to the Application required to be submitted on Deadline 1 has been updated to reflect all of the submissions and updates.

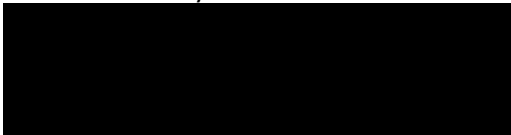
