Chapter 1: Executive Summary

Consultation Report

- 1.1.1 Associated British Ports (the "Applicant") submitted on 21 September 2023 an application for a development consent order (the "Application") under section 37 of the Planning Act 2008 (the "2008 Act") to the Secretary of State for Transport to authorise the construction and operation of the proposed Immingham Green Energy Terminal ("IGET") and associated development (collectively the "Project"). The Application was accepted for Examination by PINS on behalf of the Secretary of State on 19 October 2023. The Examination is currently ongoing, having commenced on 20 February 2024 and being due to close on 20 August 2024.
- 1.1.2 Since the submission of the original Application, the Applicant has continued to engage with stakeholders and refine the engineering design of the Project. Through this process, the Applicant has identified the need for limited changes to the Application (the "Proposed Changes"). The Proposed Changes are summarised in Chapter 2 of this Consultation Report Addendum (the "Report") and are described in more detail in Section 2 of the Proposed Changes Application Report [TR030008/EXAM/10.6].
- 1.1.3 In accordance with the Planning Inspectorate's 'Advice Note Sixteen: Requests to change applications after they have been accepted for Examination", ("AN16") the Applicant notified the Examining Authority ("ExA") of its intention to request the Proposed Changes to the Application on 26 March 2024, (the "Proposed Changes Notification"). The Applicant's Proposed Changes Notification consisted of a covering letter [REP2-027], the Proposed Changes Notification Report ("PCNR") [REP2-024], as well as providing the Notice for Proposed Changes Application ("Notice for Proposed Changes Application") [REP2-025] identifying and describing the four changes the Applicant is seeking to the submitted Application which was sent to consultees and published as part of the consultation exercise carried out in relation to the proposed Changes, and the covering letter to consultees accompanying the Notice for Proposed Changes Application [REP2-026].
- 1.1.4 The Applicant also commenced a consultation on the Proposed Changes on 26 March 2024 (the "Proposed Changes Consultation") in accordance with the approach described in the PCNR (at Chapter 7) [REP2-024], which the Examining Authority (the "ExA") described as "sound" [PD-011] in its response (the "Rule 9 and Rule 17 Letter") to the Applicant's prior request for advice on the scope of the consultation exercise to be carried out in relation to the Proposed Changes [AS-020]. The Proposed Changes Consultation lasted for a period of 30 days from 26 March 2024 until 23:59 24 April 2024 and is described further in Chapter 3 of this Consultation Report Addendum (the "Report").
- 1.1.5 This Report forms part of the Applicant's formal Change Application in accordance with item 7 of Figure 2b of AN16 and has been prepared as an addendum to the Consultation Report [APP-022] [APP-041], submitted with the original Application. The purpose of this Report is to describe the activities carried out as part of the Proposed Changes Consultation and how the Applicant has taken into account all feedback received during the Proposed Changes Consultation in finalising its formal Change Application.





Chapter 2: Introduction

Overview

- 2.1.1. The Applicant submitted the Application on 21 September 2023 to authorise the construction and operation of the Project, which was accepted for Examination on 19 October 2023. The Examination is part heard, having commenced on 20 February 2024 and is due to close 20 August 2024.
- 2.1.2. Since the submission of the Application, the Applicant has continued to engage with stakeholders and as a result of ongoing consultation, as well as design evolution, the Applicant has identified four Proposed Changes to the Project. These changes are subject of this formal Change Application and are summarised in full in the Proposed Change Application Report [TR030008/EXAM/10.6].
- 2.1.3. As detailed in this chapter, the Applicant considered PINS' AN16, as well as paragraphs 109 115 of the Ministry of Housing, Communities & Local Government's guidance, 'Planning Act 2008: Guidance for the examination of applications for development consent' ("the Guidance").
- 2.1.4. In accordance Step 1 of Figure 1 (Summary of how to make a request to make a change to an accepted application) of AN16, the Applicant notified the Examining Authority ("ExA") of its intention to request the Proposed Changes to the Application on 26 March 2024, (the "Proposed Changes Notification"). The Applicant's Proposed Changes Notification consisted of a covering letter [REP2-027], the Proposed Changes Notification Report ("PCNR") [REP2-024], as well as providing the Notice for Proposed Changes Application [REP2-025] identifying and describing the four changes the Applicant is seeking to the submitted Application which was sent to consultees and published as part of the Proposed Changes Consultation, and the covering letter to consultees accompanying the Notice for Proposed Changes Application [REP2-026].
- 2.1.5. In order to notify all parties likely to be affected by or otherwise interested in the Proposed Changes as early as possible and taking into account paragraph 114 of the Guidance, which states that "it is expected that the applicants will discuss the implications of any changes they wish to make with the relevant statutory consultees and notify the Examining Authority at the earliest opportunity" in order to "allow the Examining Authority to accommodate any appropriate consultation on the change within the six month examination period", the Applicant had previously requested the ExA's advice on the proposed scope of consultation and consultees to be included in relation to the Proposed Changes by letter on 7 March 2024 [AS-020] (the "Proposed Changes Advice Letter"), In this letter, the Applicant specifically sought confirmation of its proposed targeted approach to the Proposed Changes Consultation and enclosed for the ExA's review a list of proposed consultees and explanation for inclusions and exclusions in that list [AS-021].
- 2.1.6. The ExA issued a response dated 18 March 2024 [PD-011] (the "Rule 9 and Rule 17 Letter"), in which the ExA noted that the Applicant's targeted approach to consultation and the proposed list of parties was "sound", and confirmed the anticipated timeline for requesting the Proposed Changes is accepted to ExA, constituting Step 2 of Figure 1 of AN16. The scope of the Proposed Changes Consultation is detailed further in Chapter 3: Proposed Changes Consultation Process. The approved list of consultees for the purpose of the Proposed Changes Consultation can be viewed in Table 2 (Chapter 3) of this Addendum.
- 2.1.7. In accordance with Step 3 of Figure 1 of AN16, the Applicant has undertaken the Proposed Changes Consultation in accordance with its proposals set out in both the Proposed





Changes Advice Letter at paragraphs 2 and 3 and Section 7 of the PCNR and approved by the ExA in the Rule 9 and Rule 17 Letter. The methodology and activities carried out during the consultation period are detailed in Chapter 3: Consultation Process of this Report, which provides detail of all non-statutory targeted consultation activities undertaken to comply with the advice provided to the Applicant by the ExA.

The Applicant

- 2.1.8. The Applicant is the owner and operator of the Port of Immingham (the "Port"). Further details of the Port, and the Applicant's role and responsibilities in relation to it, are set out in paragraph 1.2 of the Environmental Statement ("ES") Chapter 1: Introduction [APP-043] and paragraphs 2.1.4 2.1.11 of the original Consultation Report [APP-022]. See also Figure 2.1 in the original Consultation Report for a Location Plan of the Port.
- 2.1.9. The Applicant is working closely with Air Products (BR) Limited ("Air Products"), in relation to Air Products' proposals to construct and operate the hydrogen production facility which forms part of the Associated Development of the Project. Air Products would be the first customer to use the IGET for the import of green ammonia to be converted to green hydrogen. Further details regarding Air Products and its role in the Project are set out at paragraphs 2.1.12 2.1.16 of the original Consultation Report [APP-022] and paragraph 1.3 of ES Chapter 1 [APP-043].

The Proposed Development

- 2.1.10. ABP has submitted the Application to the Secretary of State for Transport ("the Secretary of State") under the provisions of section 37 of the 2008 Act for development consent for the Project which if approved will, through the statutory vehicle of a development consent order ("DCO"), authorise the alteration of an existing harbour facility for the construction of a new liquid bulk terminal and associated hydrogen production facility on the eastern side of the Port and includes both marine and landside development.
- 2.1.11. A comprehensive description of the Project is set out in Chapter 2: The Project of the Environmental Statement [APP-044] which forms part of the submitted Application (noting that an updated version of Chapter 2 [TR030008/APP/6.2] has been submitted as part of this Change Application to reflect the Proposed Changes) and in paragraphs 2.1.20 2.1.28 of the original Consultation Report [APP-022]. The works comprising the Project are included in Schedule 1: Authorised Project of the draft DCO ("dDCO") [REP1-016], subject to the acceptance of the Proposed Changes for Examination which have been incorporated into the dDCO submitted as part of this Change Application [TR030008/EXAM/2.1] (noting that if the Change Application is not accepted the Applicant will submit a further update to the dDCO without the amendments to the wording made to reflect the Proposed Changes).

The Proposed Changes to the Project

- 2.1.12. The need for the Proposed Changes has arisen following the date of submission of the Application due to ongoing engagement with stakeholders and further design evolution.
- 2.1.13. Throughout the process of developing the Proposed Changes, notifying the ExA of its intentions to request the Proposed Changes, in planning and carrying out the Proposed Changes Consultation and in submitting its formal Proposed Changes Application, the





- Applicant has taken fully into account the advice provided by AN16 and paragraph 114 of the Guidance (referred to at paragraphs 2.1.3 2.1.7 above).
- 2.1.14. Paragraph 1.3 of AN16 provides that: "The justification for making a change after an application has been accepted for examination must be robust and there should be good reasons as to why the matters driving the change were not identified and dealt with proactively at the Pre-application stage. Before an applicant requests a change to its application it should carefully consider how, if it is accepted by the ExA, it will impact upon the other Interested Parties and the Examination Timetable."
- 2.1.15. To assist the ExA in deciding "whether a change requested by an applicant can be accepted and examined" (AN16 para. 2.1) and in accordance with Step 1 of AN16 the Applicant submitted its Proposed Change Notification on 26 March 2024 to the ExA, which included the relevant information set out at Figure 2a of AN16, included in Applicant's PCNR. The PCNR identifies and explains the nature of and rationale for requesting the Proposed Changes (at Sections 2 and 3 respectively) and describes the steps the Applicant has taken take to consult the relevant parties (at Section 7).

Description of the Proposed Changes

- 2.1.16. The Proposed Changes are summarised below:
- 2.1.17. **Change 1:** Change to the number of monopiles forming part of the IGET jetty berth (to be constructed as part of Work No. 1a, referred to at Paragraph 1(a)(i) of Schedule 1 (Authorised Development) and at paragraph 3(2)(a)(iii), Schedule 3 (Deemed Marine Licence) of the dDCO [REP1-016], from 2 monopiles in the original Application to 4 monopiles.
- 2.1.18. **Change 2:** Change to the diameter of the piles supporting the jetty from 1.2m to 1.575m (also forming part of Work No.1 in the dDCO and referred to at Paragraph 1(a)(i) of Schedule 1 and paragraph 3(2)(a)(i) of Schedule 3 of the dDCO) required to support the loading beneath the pipe racks, and flowing from the increased pile diameter, the distance required between the piles increases, and consequently the width of the approach jetty has slightly increased from 14m to 16m.
- 2.1.19. **Change 3:** Amendment to Site Boundary at the eastern edge of Work No. 7 (as described in Schedule 1 of the dDCO) to include additional land for temporary construction purposes and minor changes to the northern access from the A1173 to Work No. 7 (marked "AB" on the Street Works and Accesses Plan **[APP-016]**); and
- 2.1.20. **Change 4:** addition of visual detail to Work No. 1a in the Works Plans [APP-002] to show the walkways linking the jetty head to the mooring dolphins. These walkways are already described at paragraph 1(a)(i), Schedule 1 and at Paragraph 3(2)(a)(ii) of Schedule 3 of the dDCO.
- 2.1.21. The Proposed Changes were described in detail at Section 2 of the PCNR (and are further described at Section 2 of the Proposed Change Application Report [TR030008/EXAM/10.6]).

Purpose of this Report

2.1.22. This Report has been prepared by the Applicant for submission with the Change Application and provides a comprehensive description of all activities undertaken by the Applicant as part of the Proposed Changes Consultation. The Report is also an addendum





to the original Consultation Report submitted with the Application, so together the Consultation Report and this Addendum provide a comprehensive record of all consultation and engagement undertaken in relation to both the original Application and the Change Application.

- 2.1.23. This Report is prepared in accordance with the provisions of Item 7 of Figure 2b of AN16.
- 2.1.24. Step 3 of AN16 requires that "to the appropriate extent, the Applicant carries out consultation" about the Proposed Changes, and Step 4 requires the Applicant to make its formal Change Application to the ExA by "providing the relevant information set out in Figure 2". This includes, where consultation has been carried out, a Consultation Report. In accordance with Item 7 of Figure 2b, this Report contains the following information:
 - (a) confirmation of those parties consulted in relation to the Proposed Changes (Section 3, Table 2 of this Report);
 - (b) explanation of why these parties were consulted (Section 3, Table 2 of this Report); and
 - (c) inclusion of the Applicant's consideration of all responses received during the Proposed Changes Consultation, and how these responses have been taken into account in the Applicant's finalising of its Change Application (Section 4 and Table 4 of this Report).

Chapter 3: Proposed Changes Consultation Process

3.1.1. This chapter outlines the Applicant's approach to the Proposed Changes Consultation, covering legislative context, relevant guidance, and compliance, as well as describing the activities undertaken and identifying and explaining the reasoning behind the inclusion of each consultee within the Proposed Changes Consultation. The Report describes the documents which comprised the consultation materials, the activities undertaken and explains how Proposed Changes Consultation has been carried out in compliance with advice received from the ExA and with consideration to the CA Regulations.

Scope of the Proposed Changes Consultation

- 3.1.2. The purpose of the Proposed Changes Consultation was to notify all parties identified as likely be affected or otherwise interested in the Proposed Changes as early as possible, to enable them to comment on the Proposed Changes and the Applicant to be able to consider these comments in advance of making its formal Change Application. The Applicant therefore launched a targeted consultation on the Proposed Changes in accordance with the scope and approach set out in the Proposed Changes Advice Letter and approved by ExA in the Rule 9 and 17 Letter.
- 3.1.3. The Applicant's targeted approach to the Proposed Changes Consultation is consistent (to the extent appropriate) with the approach to pre-application consultation undertaken on the Project as explained in the original Consultation Report [APP-022] and second





Statement of Community Consultation ("SoCC") [APP-024]. Although Section 47 of the 2008 Act and the SoCC strictly apply only in relation to pre-application Statutory Consultation and the Proposed Changes Consultation is non-statutory, following the approach set out in the SoCC to the extent appropriate given the limited nature of the Proposed Changes provides a useful tool to the Applicant to ensure that a thorough consultation is carried out. This ensures there is a coherent approach to all consultation undertaken in relation to the Application (both statutory and relating to the Proposed Changes), and that the interests of those parties likely to be affected by the Proposed Changes are safeguarded.

- 3.1.4. In particular, the second SoCC states at paragraph 1.31 "the approach outlined in this second SoCC will also apply to any subsequent rounds of consultation" and goes on at paragraph 1.34 to state that: "it may also be necessary in the future to undertake further rounds of Statutory Consultation with specific individuals or sections of the community potentially affected by the Project and if so that consultation may be undertaken on a targeted basis (for example either a geographic or specific stakeholder basis). It is proposed any future targeted consultation on the Project is undertaken in accordance with the principles and methods set out in this second SoCC".
- 3.1.5. The targeted nature of the Proposed Changes Consultation is also in accordance with AN16, which advises at paragraph 3.3 that "as a starting point the Inspectorate recommends that applicants should consult all those persons prescribed in the PA2008 under section 42 (a) to (d) who would be affected by the proposed change" (emphasis added), and the Guidance, which states that "it is expected that applicants will discuss the implications of any changes they wish to make with the relevant statutory consultees…" (emphasis added).
- 3.1.6. Given the limited nature of the Proposed Changes, the Applicant considered that a targeted consultation exercise with a pre-determined list of consultees, as specified in Table 2, would be proportionate. The targeted consultation consisted of the Notice for Proposed Changes Application containing links to where the documents accompanying the Change Notification could be viewed (both electronically and in hard copy) being sent to those prescribed consultees, local authorities and person with an interest in land the Applicant believes will or may be affected by the proposed changes, who are specified in Table 2. As well as undertaking this targeted consultation, the Applicant also published a Notice for Proposed Changes Application (Appendix A.1) in the same local and national news sources in which the notices of the first and second Statutory Consultations were published (detailed at para 3.1.29 – 3.1.30 and Table 3 below), posted physical copies of those notices at prominent locations also used in the first and second periods of Statutory Consultation (carried out from 9 January 2023 until 20 February 2023 and from 24 May 2023 to 20 July 2023) (described at para 3.1.27 – 3.1.28), and deposited hard copy documents relating to the Change Notification (including the PCNR) at locations within the community (set out at para 3.1.26 below). This enabled those in the wider community who, although they may not be affected by the Proposed Changes, may still have wished to engage with the Proposed Changes Consultation, to do so.
- 3.1.7. In accordable with AN16, the Applicant sent to the ExA the Proposed Changes Advice Letter, seeking advice on its proposals for the scope of the consultation exercise ahead of its launch, In particular, the Applicant sought advice on its proposed list of targeted consultees, as well as explanations for inclusions and exclusions (see the list of consultees included in sent to the targeted consultation below). The justification for inclusion and exclusion of each party was provided in accordance with paragraph 3.3 of AN16, which states that "if a targeted approach to the identification of those affected by the request to





- the change application is adopted then detailed justification should be provided why it is deemed unnecessary to consult all of the prescribed persons."
- 3.1.8. The Proposed Changes Consultation commenced on 26 March 2024 and lasted for a period of 30 days until 23:59 on 24 April 2024. This 30-day period exceeds the 28-day period recommended in paragraph 3.3 of AN16 as the "starting point" for the number of days from receipt of information for consultees to respond.

CA Regulations

- 3.1.9. In designing the Proposed Changes Consultation process, the Applicant considered whether CA Regulations would be engaged by the Proposed Changes.
- 3.1.10. The CA Regulations do not apply to the Proposed Changes, for the reasons set out in the PCNR [REP2-024] and the Applicant's Response to the ExA's Request for Further Information under Rule 17 [REP2-022]. The ExA confirmed in the Rule 9 and Rule 17 Letter that it agreed that the "CA Regulations are unlikely to be engaged by the proposed changes".
- 3.1.11. On this basis, the CA Regulations do not impact the scope of consultation required for the Proposed Changes Application.

Consultees

- 3.1.12. As previously noted, the Applicant sought to conduct a targeted consultation with a predetermined list of prescribed and non-prescribed consultees identified as potentially being affected by, or having an interest in, the Proposed Changes.
- 3.1.13. The Applicant's starting point for drawing up the List was AN16's guidance, which advises that "the Inspectorate recommends that applications should consult all those persons prescribed in the PA2008 under section 42 (a) to (d) who would be affected by the proposed change", and that "if a targeted approach to the identification of those affected by the request to the change application is adopted then detailed justification should be provided why it is deemed unnecessary to consult all of the prescribed persons".
- 3.1.14. The list of proposed consultees was shared with the ExA as an appendix to the Proposed Changes Advice Letter [AS-021] as the Applicant sought advice on the proposed list of consultees. Consistent with paragraph 3.3 of AN16, the proposed list of consultees shared with the ExA considered all those parties consulted during the statutory consultations in accordance with s42(1) (a), (aa),(b),(c) and (d) of the 2008 Act, describing whether and why these proposed parties should be consultees in the Proposed Changes Consultation. The parties identified in the list of proposed consultees for inclusion in the Proposed Changes Consultation provided what the Applicant believes is a full list of those relevant prescribed consultees, local authorities and persons with an interest in land who the Applicant believes will or may be affected by the Proposed Changes.
- 3.1.15. In its Rule 9 and Rule 17 Letter in response to the Applicant's Proposed Changes Advice Letter, the ExA deemed the parties included this list, and the targeted consultation approach and activities, "sound". The Applicant carried out the Proposed Changes Consultation on the basis proposed in the Proposed Changes Advice Letter and approved in the Rule 9 and Rule 17 Letter with those parties identified in the list enclosed with the Proposed Changes Advice Letter. Table 2 below is the finalised list of parties that the Applicant considered necessary to include in the targeted consultation following the ExA's approval of the parties in the list enclosed with the Proposed Changes Advice Letter.


Overview of consultation feedback

- 4.1.1 Relevant parties and members of the public could respond to Proposed Changes Consultation by the following means:
 - Contacting the project team via the dedicated project email address (enquiries@imminghamget.co.uk);
 - Submitting an email via a comment box on the project website;
 - Calling the dedicated phone line, which was open throughout the consultation period and staffed between the hours of 09:00 18:00, Monday to Friday;
 - Posting a response to the project team via the freepost address (Immingham Green Energy Terminal, PO Box 76780, London WC1A 9SJ).
- 4.1.2 Overall, there were six responses to the Proposed Changes Application consultation. Of the statutory, non-statutory and land interest consultees identified in Table 2 of this Addendum, only the Health and Safety Executive (HSE), Environment Agency, Marine Management Organisation, Natural England and the Maritime and Coastguard Agency responded to the Proposed Changes Consultation. The sixth response was from a member of the public responding to the Notice for Proposed Changes Application published in The Times requesting a USB stick containing the PCNR. This was provided and no further communication was received. A copy of the consultation responses, together with the Applicant's responses, can be viewed below.
- 4.1.3 The Applicant has reviewed all feedback received during the consultation period and considered it in finalising its Change Application. As evident from the responses detailed below, none of the responses identified any issues with the Proposed Changes, and all expressed agreement with the Applicant's assessment that the Proposed Changes would not have any new or different likely significant environmental effects, in relation to the specific areas identified by the consultees in their responses. On this basis, the Applicant considered that no further modifications were needed to the Proposed Changes in order to make its Change Application.

The MMO has reviewed these proposed changes, in consultation with our scientific advisors at the Centre for Environment, Fisheries and Aquaculture Science (Cefas)s. The MMO's comments are below:

Benthic Ecology

The MMO does not have any concerns regarding the proposed changes with regards to benthic ecology receptors. The MMO agrees that two additional monopiles located along the same alignment as the two originally proposed, places under the deck of the Jetty Loading Platform, would not result in any new or different likely significant environmental effects to those already assessed in the original application.

The MMO also agrees with the conclusion that an increase in the diameter of two piles in each bent supporting the Approach Jetty, from 1.2 m to 1.575 m, would not result in any new or different likely significant environmental effects.

Coastal Processes

The proposed changes do not affect the capital and maintenance dredge requirements of the project (paragraph 5.2.1). Numerical modelling of the

The Applicant can confirm that the modelling of the changes used the numerical same validated modelling tools that were used within the assessment of the Project (as per the original Application). Details of the model validation can be found in an Appendix Environmental to Statement Chapter 16: Physical Processes. Appendix 16.A: Model Numerical Calibration [APP-205].

The Applicant notes that the MMO has no major concerns regarding the results and is content that the overall coastal process effects remain unchanged.

Shellfisheries

The Applicant welcomes the MMO's confirmation that it has no concerns in relation to shellfisheries.

Fisheries

The Applicant welcomes the MMO's confirmation that it has no concerns in relation to fisheries.

Underwater noise

The Applicant welcomes the MMO's confirmation that it has no concerns in relation to underwater noise.





physical impacts of the changes has been conducted but is not presented.

Permanent direct loss of intertidal habitat has increased from 0.00158ha to 0.0021ha (0.00063ha). In addition, indirect loss (due to the modelled changes in the hydrodynamics and sediment transport regime) potentially increase by 0.01ha, to 0.04ha total. Loss of subtidal habitat has also increased by 0.008ha (to 0.059ha). These losses are also in addition to those due to the adjacent Immingham Eastern Ro-Ro terminal, and the report reconsiders the combined cumulative impact also.

Habitat loses are assessed as not affecting the overall structure or function of the habitats in the local environment, and therefore impacts are assessed as insignificant (unchanged).

The MMO notes that the reassessment identifies additional habitat loss as the major physical impact of the changes. The assessment hinges on the evidence from updated physical modelling and a precautionary conceptual interpretation of the physical system – neither of which are presented in the document, thus the MMO's review of the assessment rests on unseen evidence.

However, the MMO has no major concerns that the revised impacts are not as presented and therefore is content that the overall coastal process effects remain unchanged, as assessed by the Applicant.

Shellfisheries

The MMO has no concerns relating to shellfisheries caused by the proposed changed to the project and therefore has no further comments to make regarding this.

Fisheries

The MMO does not have any concerns relating to fisheries and fish ecology as a result of proposed change 1 listed





		above, provided that the mitigation measures being discussed during Examination are agreed and conditioned on the deemed marine licence, in particular in relation to the proposed piling mitigation measures. The proposed changes 1 and 2 will result in increases in direct loss of subtidal habitat and indirect loss of intertidal habitat. However, no additional capital or maintenance dredging is required. In the original Environmental Statement, direct loss of intertidal and subtidal habitat as a result of the piles was assessed insignificant. Direct changes to benthic habitats and species beneath marine infrastructure due to shading was also assessed as insignificant. Given the modest increases in loss of subtidal habitat that will arise from the proposed changes 1 and 2, the MMO agrees that the impacts from direct and indirect loss of habitat will remain insignificant to fisheries and fish ecology, and therefore we have no concerns. 

The MCA would however expect the final scheme layout including jetty alignment, length, and berthing arrangements to be considered within the NRA, with the worst-case scenario for shipping and navigation assessment presented. We note that the Navigation Risk Assessment (NRA) has not yet been completed. The Environmental Statement should present the mitigation

The Application was accepted for Examination on 19 October 2023, and the Examining Authority was appointed 31 October 2023 to Examine the Application. The Examination of the Application commenced on 20 February 2024, and is due to close 20 August 2024.

Notice is given that the Applicant intends to submit a request to the Examining Authority to make changes to the Application (the "Proposed Changes"). A description of the Proposed Changes is set out below. In advance of submitting the request to make the Proposed Changes to the Application (the "Proposed Changes Request"), the Applicant is undertaking a public consultation on the Proposed Changes (the "Proposed Changes Consultation"). Summary of the Project

The Project for which the Applicant is seeking development consent includes a nationally significant infrastructure project ("NSIP") comprising the construction, operation and maintenance of a multi- user liquid bulk terminal which would be located on the eastern side of the Port of Immingham ("the Port") and associated development (collectively, "the Project"). The associated development would comprise the construction and operation of a green hydrogen production facility and other associated landside works for the production of green hydrogen from imported green ammonia on site.

The proposed Project consists of:

- a) The NSIP, which comprises:

- A corridor between the new jetty and Laporte Road which would support a private road (the 'jetty access road'), pipe-racks, pipelines to enable the ammonia import to the East Site (as described below), as well as security gates, a security building, a power distribution building and associated utilities.
- 2. The 'East Site Ammonia Storage' an ammonia storage tank and related plant including an ammonia tank flare stack would be constructed as well as additional buildings (including welfare building, power distribution building and a process instrumentation building), pipe-racks, pipelines, pipes, cable-racks, utilities and other infrastructure.
- 3. Construction of a culvert under Laporte Road for pipelines, pipes, cables and other conducting media linking the two parts of the East Site.
- 4. 'East Site- Hydrogen Production Facility' construction of up to three hydrogen production units and associated plant including flue gas stacks and flare stacks together with additional buildings (including process control building, power distribution buildings, process instrumentation buildings, analyser shelters), pipe- racks, pipelines, pipes, utilities and other infrastructure.
- 5. Underground pipelines, pipes, cables and other conducting media between the East and West Sites (as described below), for the transfer of ammonia, hydrogen, nitrogen and utilities, with cathodic protection against saline corrosion.
- 6. The 'West Site' construction of up to three hydrogen production units with associated flue gas stacks and flare stacks and up to four liquefier units; hydrogen storage tanks, hydrogen trailer filling stations, a hydrogen vent stack and associated process equipment; and hydrogen vehicle and trailer filling stations, hydrogen compressors and associated process equipment together with additional buildings (including but not limited to control room and workshop building, security and visitor building, contractor building, warehouse driver administration building, safe haven building, electrical substation and metering station, power distribution buildings, process instrumentation buildings, analyser buildings and additional temporary buildings during construction), process and utility plant including cooling towers and pumps, fire water tank, instrument air equipment, pipe-racks, pipelines, pipes, cable-racks, utilities and other infrastructure.
- 7. Formation of temporary construction and laydown areas on Queens Road and off Laporte Road.
- 8. Temporary removal of street furniture and modification of overhead cables on Kings Road associated with the transport of large construction components from the Port to the Site.

Air Products has over 30 years' experience operating in the Humber alone, with several sites that manufacture and distribute a range of products including facilities at Saltend, Hull and in Stallingborough, a short distance from the proposed Immingham site.

Air Products would be the first customer to use the new IGET facility once built if the planning application is successful.

Our Proposals

ABP is bringing forward proposals to construct, operate and maintain the Immingham Green Energy Terminal (IGET) – a new multi-user liquid bulk green energy terminal located on the eastern side of the Port of Immingham.

The new facility at the Port would comprise:

On the marine side (the NSIP):

- A jetty, consisting of an approach trestle, approximately 1.2km in length, leading to a single berth, including loading platforms and berthing and mooring dolphins with link walkways; and
- Topside infrastructure on the jetty for the handling of bulk liquids, including loading arms and pipelines.

On the land side:

- · A jetty access road and related infrastructure;
- Two operational sites supporting hydrogen production facilities (an East Site and a West Site);
- Pipework, pipelines and utilities (i) between the jetty and the green hydrogen production facility on the East Site and (ii) between the two green hydrogen production facility sites and (iii) between huildings and plant within the production

operation facilities;

- · Refrigerated ammonia storage tank (on the East Site);
- Hydrogen production units that convert ammonia to produce the green hydrogen (on both East and West Sites);
- Hydrogen liquefiers to liquify the hydrogen for temporary storage on the West Site;
- Loading bays to fill road tankers with liquified hydrogen which would then be distributed to hydrogen filling stations throughout the UK (on the West Site)
- A hydrogen refuelling station and bulk hydrogen trailer filling station;
- · Ancillary buildings and works;
- Access from the public highway to the two hydrogen production sites;
- · Temporary construction areas; and
- Various works (connections, diversions, protective works) to utilities including works on highways land.

Proposed Changes Consultation

As a result of ongoing engagement with stakeholders and further design evolution of the IGET project, a need has arisen to prepare a separate application for a number of Proposed Changes to the submitted draft DCO.

In summary, the Proposed Changes are as follows:

Proposed Change 1: change to the number of monopiles forming part of the IGET jetty berth (to be constructed as part of Work No. 1, referred to at paragraph 3, Schedule 3 of the draft Development Consent Order ("dDCO") [REP1-016], from 2 monopiles in the original Application to 4 monopiles;

Proposed Change 2: change to the diameter of the piles supporting the approach jetty from 1.2m to 1.575m (also forming part of Work No.1 in the dDCO) to support the loading from the pile racks, and flowing from the increased pile diameter, the distance required between the piles increases, and consequently the width of the approach jetty has slightly increased from 14m to 16m;

Proposed Change 3: Amendment of site boundary at the eastern edge of Work No. 7 to include additional land for temporary construction purposes and minor changes to the western accesses from the A1173 to Work No. 7;

Proposed Change 4: addition of visual detail to Work No. 1a in the Works Plans [AS-002] to show the walkways linking the jetty head to the mooring dolphins. These walkways are already described at paragraph 1(a)(ii), Schedule 1 and at Paragraph 3(2)(a)(ii) of Schedule 3 of the draft DCO.

The Proposed Changes are described in more detail in the Proposed Changes Notification Report.

The consultation on the Proposed Changes is taking place between Tuesday 26 March 2024, until 23:59 on Wednesday 24 April 2024.

Any person can respond to the Proposed Changes Consultation. All responses must be received by us in writing by 23:59pm on Wednesday, 24 April 2024.
