**Planning Act 2008 (as amended) ("PA2008") and the Infrastructure Planning (Examination Procedure) Rules 2010 (the "EPR")  
Application by Associated British Ports ("the Applicant") for an Order Granting Development Consent for the Immingham Green Energy Terminal ("IGET")  
Applicant's application for changes to its application for development consent ("Change Application")  
Application Reference: TR030008**

As you know we act on behalf of the Applicant in relation to the application for a development consent order (the "**Application**") for the construction, operation and maintenance of the IGET and its Associated Development (the "**Project**"). The Application was originally submitted on 21 September 2023 and accepted for Examination on 19 October 2023, which has since commenced on 20 February 2024.

Ongoing engagement with stakeholders and design evolution since the Applicant's original submission of the Application has made it apparent that there is a need for limited changes to the Application. The Applicant has had regard to the Planning Inspectorate's '*Advice Note Sixteen: Requests to change applications after they have been accepted for examination*' ("**AN16**") throughout the process of notifying, consulting on and finalising its Change Request, and in accordance with Step 4 of Figure 1 (summary of how to make a request to make a change to an accepted application) of AN16, the Applicant is now formally seeking the ExA's consent to include the Proposed Changes to the Application in the Examination. This letter and its accompanying documents constitute the Applicant's Change Application, and include the information required in Figure 2b (What to include in the Change Application) of AN16. A list of the documents accompanying the Change Application is set out in Table 1 below, and details of the steps taken to comply with the requirements of Figure 2b are set out at Table 2 in Annex A.

**1 Prior Notification of Proposed Changes**

1.1 In accordance with Step 1 of Figure 1 of AN16 the Applicant made its formal Change Notification to the Examining Authority ("**ExA**") on 26 March 2024, notifying the ExA of the Applicant's intention to propose four changes (together the "**Proposed Changes**") to the Application. The Applicant sent to the ExA along with its covering letter (the "**Notification Letter**" [REP2-027]) the Proposed Changes Notification Report (the "**PCNR**") [REP2-024] which identified the nature of the Proposed Changes to the Project, and contained the required information set out in Figure 2a (Information to include in a Change Notification) of AN16.

## 2 Proposed Changes Consultation

2.1 Also on 26 March 2024, the Applicant launched its consultation on its Proposed Changes (the "**Proposed Changes Consultation**") for a period of 30 days, commencing on **26 March 2024** and remaining open until **23:59 on 24 April 2024**, fulfilling Step 3 of Figure 1 of AN16.

2.2 Prior to the Applicant's Change Notification, the Applicant had written to the Examining Authority ("**ExA**") on 7 March 2024 requesting advice on the scope of the Proposed Changes Consultation [**AS-020**] (the "**Proposed Changes Advice Letter**") and in accordance with Step 2 of Figure 1 of AN16, the ExA responded on 18 March 2024 [**PD-011**], confirming that the Applicant's proposed approach to consultation and suggested list of consultees provided with the Proposed Changes Advice Letter [**AS-021**] was "sound".

2.3 The Proposed Changes Consultation was therefore carried out in accordance with the procedure described in the Proposed Changes Advice Letter and approved by the ExA. The Proposed Changes Consultation is further described in Section 7 of the PCNR, Section 6 of the Proposed Change Application Report (the "**PCAR**") accompanying this letter [**TR030008/EXAM/10.6**] and the Consultation Report Addendum [**TR030008/EXAM/10.19**], and consisted of targeted consultation and publication of notices of the Applicant's intention to apply for the Proposed Changes (the "**Proposed Changes Notice**") in the local and national press as well as placing physical copies of the Proposed Changes Notice in prominent locations around the Application site and the wider area. The consultation materials (i.e. the PCNR and the Proposed Changes Notice) were also made available electronically for viewing and/or download from the Project website, and physical copies were deposited at the Immingham Town Council Civic Centre and Grimsby Public Library.

2.4 Following the conclusion of the Proposed Changes Consultation, the Applicant has now finalised its formal Change Application after having fully considered all responses received during the consultation period. Chapter 4 of the Consultation Report Addendum includes all feedback received during the Consultation Period, as well as the Applicant's responses. All statutory consultees that responded expressed overall agreement with the Applicant's assessment of the fact that the Proposed Changes would not result in any new or different likely significant environmental effects in relation to the consultee's particular areas of concern, and no issues were raised with the Proposed Changes. As a result the Applicant is submitting its Change Application on the basis and description of the Proposed Changes as set out in the Change Notification materials.

## 3 Proposed Changes and the Change Application

3.1 The details of the Proposed Changes are described in detail at Section 2 of the PCAR. For the ExA's assistance, the Proposed Changes are also summarised here:

- **Proposed Change 1:** Increase in Number of Monopiles
- **Proposed Change 2:** Increase in Pile Diameter and Approach Jetty Width
- **Proposed Change 3:** Minor Change to the Red Line Boundary in the Vicinity of Work No. 7 and Minor Changes to the Northern Access from A1173 to Work No. 7; and

- **Proposed Change 4:** Addition of Visual Detail to the Works Plans [**AS-002**] at Work No. 1a.

3.2 The PCAR also includes an explanation of the rationale and pressing need for making the Proposed Changes (Section 3), confirmation as to the position regarding new or different likely significant environmental effects as a result of the Proposed Changes (both alone and in combination) (Section 4), gives an update on the effect of the changes on any consents and licences required (section 5), and describes the consultation being carried out on the Proposed Changes and addresses compliance with the Infrastructure Planning (Compulsory Acquisition Powers) Regulations 2010 (the “**CA Regulations**”) which the Applicant confirms are not engaged by any of the Proposed Changes.

3.3 The PCAR confirms that none of the Proposed Changes, whether individually or in combination, fundamentally change or materially affect the nature or substance of the Project as originally submitted in the Application, nor do the Proposed Changes give rise to any materially new or different environmental effects in comparison to those assessed and reported in the Environmental Statement submitted as part of the Application [**APP-042**] – [**APP-225**] (see Section 5 and Appendix 4 of the PCNR, and Section 4 and Appendix 5 of the PCAR, for discussion of the environmental effects of the Proposed Changes).

#### 4 **Submission of Updated and Additional Documents**

4.2 In addition to the above list, Appendix 1 to the PCAR **[TR030008/EXAM/10.6]** contains a full schedule of all the Change Application documents and plans, listing consequential revisions to each document and plan. Documents and plans not listed in Appendix 1 are not proposed to be updated in light of the Change Application. There are no changes to the

consents or licences required as a result of the Proposed Changes, and there is no reason why these Proposed Changes would create any impediment to securing the necessary consents or licences before conclusion of the Examination.

- 4.3 Certain of the documents that are proposed to be updated to reflect the Proposed Changes also reflect amendments that do not form part of the Change Application. For clarity, Appendix 1 describes only those changes made to the documents to reflect the Proposed Changes. The Applicant’s Cover Letter to its Deadline 3 submissions **[TR030008/EXAM/9.70]** includes reference to other documents and plans submitted which do not form part of the Change Application. The approach taken to documents submitted at Deadline 3 (both those in relation to the Change Application and other documents required to be submitted) is that one version of these documents has been submitted. Those documents where changes have been made as a result of the Proposed Changes would be re-submitted at a later Deadline if the Proposed Changes are not accepted into the Examination.
- 4.4 An updated Appendix 18:A Flood Risk Assessment (FRA) has been submitted with the Change Application. The only change made to the FRA was to substitute the figures update plates 1, 2, 3 and 5 in the document with updated figures plates to show the amended redline Order Limits. This document has been amended because the dDCO includes a requirement to comply with this Application document and therefore it has been amended to ensure it shows the correct redline Order Limits for the Application.
- 4.5 In relation to the Environmental Statement Volume 2 Figures **[APP-069 to APP-166]**, the full suite of Figures were assessed against the Proposed Changes and only those Figures that required an update in light of the Proposed Changes have been included in the Change Application. The updated Environmental Statement Volume 2 Figures, listed in Appendix 1 in the Proposed Change Application Report **[TR030008/EXAM/10.6]**, have been submitted with the Change Application as they depict the update to the Order Limits as a result of Proposed Change 3.

**5 Applicant’s compliance with AN16 Figure 2b requirements**

- 5.1 In preparing its Change Application the Applicant has had regard to the Items set out in Figure 2b (What to include in the Change Application). Table 2 below describes where the required information is located in the documents submitted as part of this Change Application.

## 6 **Accommodating the Examination of the Proposed Changes within the statutory timeframes**

- 6.1 The Applicant considers that, subject to ExA's agreement, the consideration of the Change Application can be accommodated in the statutory timescale of the remaining Examination, given:
- 6.1.1 The Proposed Changes are all of a limited scale and are not so substantial as to constitute a materially different project;
- 6.1.2 The Proposed Changes do not require any new powers of compulsory acquisition and do not engage the CA Regulations, and the consent of the owner of the land in relation to

which additional powers of temporary possession are being sought as part of Proposed Change 3 has been obtained (see Appendix 6 of the PCAR);

- 6.1.3 No new or different likely significant environmental effects have been identified as a result of the Proposed Changes (both alone and in-combination);
- 6.1.4 All parties likely to be affected by or who have an interest in the Proposed Changes were consulted in advance of submission of the Change Application, and no new issues were identified by any consultees, and all feedback received indicated agreement with the Applicant's conclusion that there would be no new or different likely significant environmental effects from those already set out in the Applicant's Environmental Statement [APP-042] – [APP-225] due to the Proposed Changes; and
- 6.1.5 The submission of the Change Application at this stage provides sufficient time to review and examine any relevant concerns that may emerge relating to the Proposed Changes.


## 7 **Next Steps**

- 7.1 The Applicant understands that once the Change Application has been submitted, the Examining Authority will make a Procedural Decision as to whether it will accept the Proposed Changes into the Examination. If the ExA decides to accept the Proposed Changes for Examination, its Procedural Decision will also detail how the changed Application will be Examined.
- 7.2 On the basis that these are minor changes not resulting in any new or different likely significant environmental effects and in light of the fact that no issues were raised with the Proposed Changes by any consultees during the Proposed Changes Consultation, the Applicant considers that the Proposed Changes are capable of being fairly examined within the Examination period.
