## 1 Introduction

- 1.1.1 This Guide to the Application accompanies an application submitted by Associated British Ports (“ABP”, or “the Applicant”) to the Secretary of State for Transport for development consent to construct and facilitate the operation of a multi-user liquid bulk green energy terminal, the Immingham Green Energy Terminal (“IGET”) and an associated hydrogen production facility on the eastern side of the Port of Immingham (collectively the “Project”), under the provisions of section 37 of the Planning Act 2008 (“PA 2008”) for a Development Consent Order (“DCO”). The IGET is classified as a Nationally Significant Infrastructure Project under section 14(1)(j), 24(2) and 24(3)(c) of the PA 2008 and the associated hydrogen production facility and landside works are classed as associated development under section 115 of the PA 2008.
- 1.1.2 This Guide to the Application has been prepared in accordance with Regulation 5(2)(q) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (“APFP Regulations”) as a document which ABP considers necessary to support the application. The following section explains the purpose of this document in the context of the DCO application.

## 2 Purpose of this Guide to the Application

- 2.1.1 This Guide to the Application provides an overview of the documents that have been prepared in order to satisfy the APFP Regulations, the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 and section 37 of the PA 2008.
- 2.1.2 Regulation 5 of the APFP Regulations sets out the documents that all DCO applications must include. It also provides in Regulation 5(2)(q) for the submission of 'any other documents considered necessary to support the application' as well as at Regulation 5(2)(o) for 'any other plans, drawings and sections necessary to describe the proposals. Regulation 6 of the APFP Regulations sets out the specific documentation required in support of DCO applications for particular types of development, including the construction or alteration of harbour facilities. This document provides a full list of documents prepared to meet the requirements of Regulation 5 and 6 of the APFP Regulations.
- 2.1.3 This Guide to the Application is a live document that will be updated as part of the Applicant's submission for each Examination deadline, where requested by the Examining Authority ("ExA") both to capture the latest versions of updated documents and to record new documents submitted as part of the Examination.
