I write on behalf of Anglian Water Services (IP Ref: 20047067 and IMGN-AFP036) and can advise that we made no comments on the Proposed Changes Consultation.

AWS is progressing water supply and water recycling solutions for the project with the Immingham GET team and specifically Air Products. These matters, as set out in our Relevant Representation, should we consider be the subject of a Water Resources Assessment that forms part of the final EIA during Examination and be the subject of a Requirement in the draft DCO and is then submitted (as updated) WRA as a pre commencement Requirement to the Local Planning Authority. We have sought support for this new approach to water resources assessment from the Environment Agency and North East Lincolnshire Council. The objective is to further improve the water efficiency of the project ahead of final design and construction commencement in order to sustainably manage water resources.

AWS is seeking a revision to the draft DCO and the inclusion of the pre-commencement Requirement. AWS would wish to have the matter resolved as part of our SoCG with the applicant before final SoCG are required on 15 August 2024.
