Dear Sirs

We act on behalf of CLdN Ports Killingholme Limited (**CLdN**) in relation to its objection to the proposed Immingham Green Energy Terminal DCO (**the Project**, case reference: TR030008), applied for by Associated British Ports (**the Applicant**).

Negotiations between the Applicant and CLdN over a form of protective provisions (**PPs**) for CLdN's benefit, and corresponding side agreement, have been ongoing. The parties have now agreed a form of PPs, which the Applicant has included in the latest version of the draft DCO submitted at Deadline 5 of the Examination, and the side agreement has been completed.

Therefore, and subject to the continued inclusion of the agreed form of PPs in the final version of the draft DCO submitted to the Secretary of State, CLdN withdraws its objection to, and prior representations regarding, the Project as accepted for examination.
