1 Introduction

1.1 Overview

- 1.1.1 This Guide to Environmental Information has been produced to support the application for Development Consent Order (“DCO”) for a multi-user liquid bulk green energy terminal, the Immingham Green Energy Terminal (“IGET”) and associated development (including a hydrogen production facility) at Immingham (collectively, the “Project”), under the provisions of Section 37 of the Planning Act 2008.
- 1.1.2 It provides a list of the documents which comprise the Environmental Statement and captures the final version of each of the relevant documents, identifies certain other key documents containing environmental information (**Section 1.2**) and provides an update on the position relating to the residential properties at Queens Road (**Section 1.3**).
- 1.1.3 This list is not an exhaustive list of environmental information as defined under the Infrastructure Planning Environmental Impact Assessment Regulations 2017 (which includes representations duly made by any person on the environmental effects of the Project) but has been prepared to help signpost the key environmental information documents submitted as part of this DCO application by the Applicant.

1.2 Environmental Information

- 1.2.1 The purpose of this part of this document is to provide a list of the documents which comprise the Environmental Statement (as set out in Schedule 15 of the **draft Development Consent Order [TR030008/APP/2.1 (9)] [REP7-0041]** and to be certified by the Secretary of State) as well as identifying certain other key documents containing environmental information .
- 1.2.2 **Table 1** below lists and provides a link to each document, along with the associated Examination library reference number and final revision number of the document. In order to assist the Examining Authority, **Table 1** also highlights some of the other key documents containing environmental information submitted into the Examination. However, as noted in the introduction above, **Table 1** should not be regarded as definitive in this regard, given that many of the documents submitted into the Examination relate to or refer to environmental information and are not all listed individually below.

1.3 Queens Road

- 1.3.1 The Environmental Impact Assessment reported in the Environmental Statement took account of the residential or mixed residential / commercial units on Queens Road (being those within plots 5/3, 5/4, 7/15 – 7/18 and 7/20-7/23 on the land plans) which at the time of the assessment were in residential use.

- 1.3.2 The Applicant confirms that those units have now been acquired by Air Products (BR) Limited and their use for residential purposes has ceased, as indicated in the **Deadline 6 Cover Letter [REP6-001]**.
- 1.3.3 During the preparation of the Environmental Statement, it was assumed that those units would not be occupied for residential purposes from the point in time at which the hydrogen production facility became operational. Requirement 14 prevents Work No. 7 from being brought into operational use until those residential properties have been acquired and their residential use has ceased. Powers of compulsory acquisition were included in the draft DCO.
- 1.3.4 However, on a precautionary basis, the Environmental Impact Assessment assessed the likely significant effects from the construction of the development on the occupiers of the residential units on the basis that those units might remain in occupation during the construction phase (in case the commencement of development took place ahead of completion of acquisition of all of those units, whether by agreement or through the use of powers of compulsory acquisition).
- 1.3.5 As the acquisition of those units has completed and their residential use has ceased, it is not considered that any likely significant effects on the occupiers of those units (as receptors) will arise during the construction period.
- 1.3.6 **Table 2** below summarises the conclusions of the relevant assessments of likely significant effects presented within the Environmental Statement specifically in relation to those residential properties on Queens Road. Only one likely significant residual effect is identified, which is the major adverse effect on the residents of those properties on Queens Road of the visual impact of the construction works (specifically Viewpoint 11: Kings Road). Two potential effects on those residents arising from noise and vibration are also identified, which, post-mitigation, are assessed as non-significant residual effects. As a result of the cessation of residential use of the properties, however, those effects would not now occur.
