## Planning Act 2008 (as amended) ("PA 2008"), the Infrastructure Planning (Examination Procedure) Rules 2010 Application by Associated British Ports ("the Applicant") for an Order Granting Development Consent for the Immingham Green Energy Terminal ("IGET") Letter to Secretary of State Application Reference: TR030008

We act on behalf of the Applicant in relation to the application for a development consent order (the "**Application**" and the "**DCO**") for the construction, operation and maintenance of the IGET and its Associated Development. The Application was originally submitted on 21 September 2023 and accepted for Examination on 19 October 2023, which commenced on 20 February 2024, and closed on 20 August 2024.

The Applicant wrote to the Secretary of State providing updates on matters since the close of Examination on 14 November 2024. The Secretary of State's response dated 21 November 2024, amongst other things, requested any further update from the Applicant on outstanding matters by 16 December 2024.

Paragraph 3 of the Applicant's letter of 16 December 2024, setting out such updates, informed the Secretary of State that completion of the flood defence agreement with the Environment Agency referred to in that letter was imminent and a further update in that regard would follow shortly.

This letter on behalf of the Applicant is that further update.

The Applicant notes that Annette Hewitson, Principal Planning Adviser at the Environment Agency, yesterday emailed a letter dated 17 December 2024 to the Secretary of State (appended) confirming (amongst other things) as follows:

- The flood defence agreement has been completed (which the Applicant confirms is the case).
- The Environment Agency agrees the form of protective provisions to be included in the draft DCO (Schedule 14, Part 2) at Appendix 3 to the Applicant's letter dated 14 November 2024.
- The Environment Agency withdraws its objection to the Application.

The Applicant would be pleased to answer any queries which you may have on this letter.

Application by Associated British Ports ("the Applicant") seeking Development Consent for the Proposed Immingham Green Energy Terminal Project ("the Proposed Development")

I write with reference to my previous letter to you on 6 December 2024 regarding the above project.

I am pleased to confirm that the legal agreement to secure the future maintenance of the flood defence that would be oversailed by the proposed jetty has today been completed. Therefore, the Environment Agency is now satisfied that the proposed development accords with the National Policy Statement for Ports (January 2012) and in particular the 3<sup>rd</sup> bullet point of paragraph 5.2.16 (flood risk exception test).

Accordingly, the Environment Agency **withdraws its objection** to the application and confirms it is satisfied that the legal agreement will ensure that the proposed works will be carried out in a way that will safeguard the appropriate level of flood protection and maintenance during the construction works and into the future. I can also confirm that the protective provisions for the Environment Agency, included in the draft Development Consent Order (Schedule 14, Part 2), sent to you as Appendix 3 to the Applicant's letter dated 14 November 2024, are also agreed.
