Application by Associated British Ports for an Order granting Development Consent for the Immingham Green Energy Terminal project

Notice of the decision by the Secretary of State

The Planning Inspectorate previously consulted you on the above project, which has now been decided. This letter notifies you of the publication of the Secretary of State's decision in relation to the above application.

The Secretary of State as the decision maker under s103 and s104 of the Planning Act 2008 (as amended) (PA2008) has decided that development consent should be granted, and therefore has made a Development Consent Order under s114(1)(a) of PA2008, which includes the requirements attached to the decision. The statement of reasons sets out the main reasons and considerations on which the decision is based, including relevant information about transboundary considerations and the participation of the public.

High Court proceedings

There is no right of appeal under PA2008. The High Court may entertain proceedings to question an Order granting development consent from the day on which the Development Consent Order is published or, if later, the day on which the decision letter is published. The procedure is to make an application for judicial review. This must be done within the statutory period of time set out in s118 of PA2008.
