## **1 Introduction**

- 1.1 This Statement of Common Ground ("SoCG") has been prepared by North Somerset District Council ("the Applicant") to set out the areas of agreement and disagreement with Wessex Water Services Limited ("Wessex Water") in relation to the Development Consent Order ("DCO") application for the Portishead Branch Line (MetroWest Phase 1) ("the DCO Scheme") based on consultation to date.
- 1.2 This SoCG comprises an agreement log which has been structured to reflect topics of interest to Wessex Water in relation to the application for the DCO Scheme. Topic specific matters agreed between Wessex Water and the Applicant are included.

## **2 Scheme overview**

- 2.1 The Applicant has applied to the Planning Inspectorate ("**PINS**") for a DCO to construct the Portishead Branch Line under the Planning Act 2008 ("the Application"). The Application was made on 15 November 2019 under reference TR040011 and was accepted for examination on 12 December 2019. The Examination opened on 19 October 2020 and is scheduled to close on 19 April 2021.
- 2.2 The DCO Scheme will provide an hourly (or hourly plus) railway service between Portishead and Bristol Temple Meads, with stops at Portishead, Pill, Parson Street and Bedminster.
- 2.3 The DCO Scheme comprises the Nationally Significant Infrastructure Project ("NSIP") as defined by the Planning Act 2008 to construct a new railway 5.4 km long between Portishead and the village of Pill, and associated works including a new station and car park at Portishead, a refurbished station and new car park at Pill and various works along the existing operational railway line between Pill and Ashton Junction where the DCO Scheme will join the existing railway. Ashton Junction is located close to the railway junction with the Bristol to Exeter Mainline at Parson Street.<sup>1</sup>

### **3 Overview of Engagement**

#### **Introduction**

3.1 This section briefly summarises the consultation that the Applicant has had with Wessex Water. For further information on the consultation process please see the Consultation Report (DCO Document Reference 5.1).

#### **Pre-application**

3.2 The Applicant has engaged with Wessex Water on the DCO Scheme during the pre-application process, both in terms of informal non-statutory engagement and formal consultation carried out pursuant to Section 42 of the Planning Act 2008. The Applicant had numerous meetings, calls and email exchanges with Wessex Water. Key meetings with Wessex Water took place on the following dates:

- 12 April 2016
- 21 July 2017
- 7 February 2018
- February 2019
- 21 June 2019

3.3 Since June 2019, further meetings have been offered to Wessex Water and the Applicant has called and emailed Wessex Water numerous times during 2020.

#### **Post-application**

3.4 The Applicant has sought to engage with Wessex Water in relation to draft Heads of Terms sent to them on 16.08.2019 and also in relation to agreeing Protective Provisions as detailed in a letter from the Applicant's Legal representatives sent to Wessex Water on 07.11.2019. Whilst progress was

initially slow, both parties have more recently been engaged in constructive discussions particularly during the course of January and February 2021.

### **Overview of key issues raised at Section 42**

- 3.5 Wessex Water did not provide any formal comments at Section 42.
- 3.6 Wessex Water made informal comments during the Applicant's previous meetings and other engagement with them which can be summarised as follows:
- (i) Confirmation of who will own and maintain the various new drainage proposed to be constructed by the Applicant;
  - (ii) Details of what the temporary land requirements were needed for by the Applicant;
  - (iii) Whether the overbuild of the 900mm foul sewer by the Applicant from Portishead Station is acceptable to Wessex Water / that they are happy with the no-divert solution being proposed by the Applicant;
  - (iv) Wessex Water would require a formal right of access to Portbury Hundred Pumping Station (plot 04/45) granting to them by the Applicant, they only have prescriptive rights currently to this;
  - (v) Wessex Water will need a permanent right of access to the foul sewer manhole at Clanage Road for ongoing maintenance (plot 15/10);
  - (vi) At Ashton Gate Underpass, plots 15/25 and 16/25 Wessex Water's foul sewer would be impacted by the proposed pedestrian bridge here, they are happy if the Applicant re-locates this in the adjoining landowner's property and this become a privately owned sewer.
- 3.7 The Applicant considered these issues during the further development stages of the DCO Scheme.

### **Overview of key issues raised after application acceptance: Relevant Representations**

- 3.8 Wessex Water have not raised any relevant representations.
