MetroWest Phase 1: Draft Development Consent Order (dDCO)

Schedule of drafting changes for dDCO submitted to the Secretary of State for Transport

20 September 2021

- 1. The following table has been prepared by the Applicant to set out the changes made to the dDCO from that submitted following the close of Examination to the Secretary of State for Transport on 9 August 2021 at Annex 1.
- 2. It is submitted together with:
 - a. Revised dDCO (DCO Document Reference: 3.1, version 10) (clean), and
 - b. A comparison version of the dDCO showing all changes between new Version 10 and Version 9 (DCO Document Reference: 3.1, version 10).
- 3. The changes are made principally to reflect the consequential changes due to the removal of Trinity foot and cycle bridge as required by the Secretary of State for Transport in item 3 of the Secretary of State for Transport's letter dated 13 August 2021, and submission of revised protective provisions and agreements between the Applicant, Bristol Port Company, Western Power Distribution and National Grid following further negotiations conducted after the close of examination. The revised dDCO also encapsulates changes made to the Environment Agency's protective provisions in respect of a duplication contained in the previous draft and changes to requirements related to Portbury Ditch as required by item 2 of the Secretary of State for Transport's letter.
