> This is a request for information under the Freedom of Information Act (FOIA) and/or Environmental Information Regulations (EIR).

>

> As a member of Portishead Railway Group (PRG) I, along with many in Portishead, was deeply disappointed at the decision to put back the deadline for the DCO decision to April 2022. I am also aware of the explanation from the DfT to our MP, Dr Liam Fox, which was conveyed to the Chairman of PRG with the claim that the delay was for further consideration of environmental issues to forestall Judicial Review by Extinction Rebellion and other groups.

>

> The explanation is not at all credible, and I do wonder if the Secretary of State for Transport is delaying in order to redirect funds for Portishead rail to other, more marginal Parliamentary constituencies in the "red wall". If that is the case then he's looking to stop Portishead rail, and that is far more likely to bring a Judicial Review from disaffected residents of North Somerset than anything Extinction Rebellion might consider in relation to the DCO.

>

> Turning to the point about Extinction Rebellion and other rabble that might seek Judicial Review. It is simply not credible. Firstly, these groups are not that structured; they are more like a strange brand that indulges in quick tactical acts, not long term legal strategies. I note also that today it was reported the Ministry of Defence was looking to get a member of Extinction Rebellion to speak to senior personnel in the Ministry and Armed Forces; are we seriously expected to believe they would oppose a DfT green initiative like reopening of a rail line when they are prepared to speak to the military?

>

> Secondly, Judicial Review is there to ensure that government decisions are in accordance with the law, and that there have been no procedural defects in arriving at the decision. The DCO for Portishead rail has been a model for following the law and procedure; in fact National Infrastructure Planning had a section and public session specifically on environmental issues. Any objections have been overcome or withdrawn. No Judicial Review has any realistic chance of proceeding beyond application.

>

> Thirdly, government and MPs more generally should be deeply concerned by the DfT stance politically, because it implies that these groups are actually succeeding in their political aims; they are actually causing a Secretary of State to pause or stop legitimate policy and delivery, even when there is no need to such as in the case of Portishead rail. That will be very embarrassing to government when it becomes publicised, as it will if Secretary of State does not approve Portishead Rail after accepting there are no DCO concerns remaining.

>

> Fourthly - and this follows on from the third point - the implication of the DfT stance due to their alleged concerns about Extinction Rebellion etc is that EVERY transport project will be subject to an extra environmental review even after it's all been done, such as shown in the DCO. Is that now DfT policy? I don't believe it is, but we should be told.

>

> I would therefore be grateful for the following information from the Department for Transport, under the FOIA and/or EIR:

> 1. Is it now DfT policy that EVERY transport project be subject to extra environmental review, because Secretary of State is worried by these groups?

You requested the following:

I would therefore be grateful for the following information from the Department for Transport, under the Freedom of Information Act and/or Environmental Information Regulations:

1. Is it now DfT policy that EVERY transport project be subject to extra environmental review, because Secretary of State is worried by these groups?
2. If it is not general policy, why has Portishead Rail been singled out for it when all Environmental objections have been met or withdrawn in the DCO process?

In regard to questions 2, 3 and 4 of your request it is considered that these fall under the EIRs. This is because the information you have sought disclosure of does, in our view, fall within the definition of 'environmental information' as defined in Regulation 2 of the EIRs.

However I can confirm that the Department does hold the information which falls within the scope of your request for the reasons outlined below.

1. This is not the Department's policy. Development Consent Order applications are assessed by the Department on their individual merit.
2. For all applications for a DCO, the Secretary of State can extend the decision deadline where he considers it necessary to do so. The extension to the decision deadline for the application to the Portishead DCO was to 19 April 2022. Since this extension was announced, details of the information requested from the Secretary of State and responses to these requests are published on the project page of the Planning Inspectorates website and can be viewed [here](#).
3. As stated above this is not a Departmental policy.
4. There is no environmental review related to this application.

I write in response to your letter of 8th December 21 to the DfT.

The Ashton Vale Road ramp (formally work No 27) was deleted from the scheme during the DCO examination. The draft Order makes no reference to Ashton Vale Road ramp, consequently neither NSC, WECA nor NR will have powers from the Order for delivery of a ramp at Ashton Vale Road.

The document you have referred to in your letter is the Schedule of Mitigation which states:
"Design of shallow gradient ramps for the Trinity School Bridge, Pill station, and (if used) the Pedestrian and Cycle Ramp between Ashton Vale Road and Ashton Road."

Please take this letter as formal confirmation that the ramp at Ashton Vale Road has been deleted from the draft Order, the scheme is no longer pursuing the delivery of the ramp and no powers for the delivery of the ramp will be included in the Order, (in anticipation of the Order being made by the Secretary of State shortly).

Dear Grant

Following the surprise decision to delay the DCO for Portishead railway, I wanted to raise a few points with you in advance of the more detailed letter from North Somerset Council which will follow soon.

First, the [project's external legal advisers](#) are surprised at the level of the perceived threat of a JR from environmental groups which seems to have motivated the decision. Can someone explain why the Department reached that view and at what level legal advice was given?

Second, if the DCO is delayed beyond mid-January, it will set back the whole project by a year due to the seasonal constraints on [ecological enabling works](#). While [the main construction work](#) would have started in [October 2022](#), a delay beyond mid-January will almost certainly mean that the project will not be completed before the next general election.

Third, delay beyond mid-January will result in disproportionate extra costs which the Council will have no alternative but to ask the Department of Transport to bear. In the current financial climate the project would otherwise be put at existential risk.

I hope that there will be urgent follow up between your civil servants and North Somerset Council as public opinion has not been sympathetic to the arguments put forward so far.


