The Applicant encloses ES Figure 10.001 (as well as Figures 10.002, 10.003 and 10.004) which were missing from the Application submission.
ES Appendix 10.1 (in Annex 10.1.1) (Doc 6.2) illustrates the locations of nature conservation sites within 2km of the application site, although this is not labelled to denote which type of designation applies (e.g. Site of Special Scientific Interest (SSSI); Local Wildlife Site). There are two SSSIs outside of the 2km study area for nationally designated sites which are not shown on a plan and would presumably be identified on Figure 10.001. However, an assessment has been provided in ES Chapter 10 (Document 6.2) which concludes there would be no likely significant effects on these SSSIs.	This relates to a 3 rd party figure (from the Biological Records office - SERC). A legend to those Figures is provided with this response, which sits with Annex 10.1.1.
