Obviously I am against the construction of the West Midlands Interchange for all the reasons already quoted, use of greenbelt land, pollution, damage to the environment, building such a huge industrial interchange in a rural area etc etc.

My question to the Open Forum would be about traffic management. I live in Wheaton Aston. There are two main roads out of the village and both lead onto the A5. Presently if you need to turn right onto the A5 towards Telford it can take some time. If there are problems on the M6 or M54 then it becomes very difficult and dangerous. If the West Midlands Interchange is built, what provision is being made for traffic management? It will become virtually impossible to turn right onto the A5 and I anticipate accidents and even fatalities. Which is totally unacceptable for people living in the area.
