**Application for an Order granting Development Consent for the construction of a Rail
Freight Interchange and associated development (West Midlands Interchange)**

Further to the above, I enclose the following updated documentation, which we considered it would be useful to submit to the Examining Authority in advance of the upcoming hearings and in the absence of any other "Examination Deadlines" between now and then.

The documentation sent is as follows:

1. Updated Framework Ecological Mitigation and Management Plan (one clean version and one highlighting the changes made since the Application submission) (Appendix 10.4 to the Environmental Statement). The changes reflect discussions with the County Council and are as indicated in the Applicant's various responses to ExQ1 (**Document 10.1**) and to Other Parties' Deadline 2 Submissions (**Document 11.1**);
2. Updated draft Development Consent Obligation (DCOb) (**Document 7.7D**) (tracked and clean). The tracked version shows changes made since the previous draft submitted to the Examining Authority on 11 February 2019 (**Document 7.7C**) and reflects various discussions with the local authorities, in addition to the changes made to the draft Development Consent Order in moving some obligations in to the requirements and vice versa, as indicated in the Applicant's various responses to ExQ1 (**Document 10.1**) and to Other Parties' Deadline 2 Submissions (**Document 11.1**). It is still a working draft, not yet agreed; and
3. Updated Site Wide Travel Plan (Appendix H to the Transport Assessment, being Appendix 15.1 to the Environmental Statement) and updated Site Wide HGV Management Plan (Appendix I to the Transport Assessment, being Appendix 15.1 to the Environmental Statement). The updates reflect discussions with the highway authorities and these documents are also referred to in the updated DCOb.

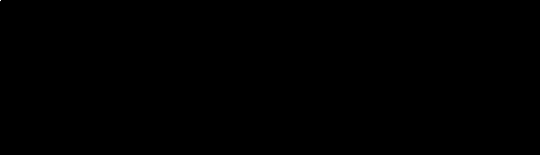
