Unfortunately I am unable to attend the Hearing on 5th June as I have a previous appointment. I would however like to pose a question about traffic.

I live in Wheaton Aston and the two main exits from the village lead onto the A5. Normally if people wish to leave the village to go towards Telford and the A41 they leave the village along the lane which joins the A5 near The Bradford Arms. Traffic then needs to turn right onto the A5. It has always been a challenge to turn right at this junction, but if there is ever a problem on the M6 or M54 then it is virtually impossible to safely make that right turn. If the Interchange is built I can envisage this junction being a deathtrap. My question is what allowance has been made to make these junctions safe, with either traffic islands or traffic lights? Have these difficulties been taken into consideration?
