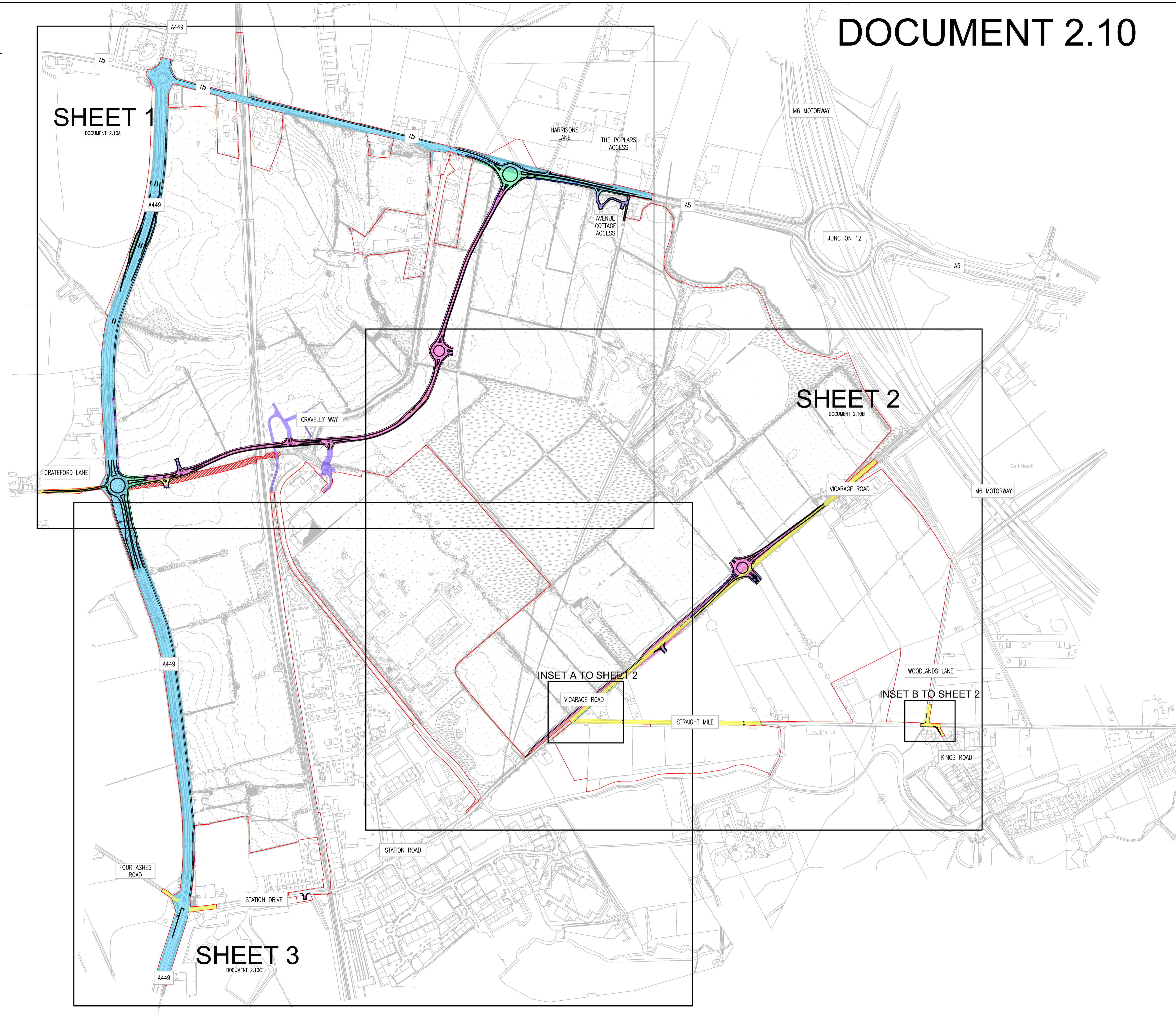
CHANGES MADE TO DOCUMENT 2.10 SINCE DCO SUBMISSION:

- MAY 2019 –
- EXTENT OF TRUNK ROAD NETWORK TO EAST OF A449 ROUNDABOUT MOVED EAST IN RESPONSE TO COMMENTS FROM HIGHWAYS ENGLAND IN THE RSA AND AS A RESULT, THE ACCESS TO THE RAIL TERMINAL HAS BEEN RELOCATED TO THE EAST.
  - ADDITIONAL LAND TO BE MAINTAINABLE BY HIGHWAYS ENGLAND AROUND THE A449 AND A5 ROUNDABOUTS TO ENSURE VISIBILITY IS MAINTAINED.
- JULY 2019 –
- AMENDMENT TO CROSSING OF LINK ROAD IN RESPONSE TO COMMENTS FROM HIGHWAYS ENGLAND AND RSA.
- AUGUST 2019 –
- AMENDMENT TO CROSSING ON LINK ROAD IN RESPONSE TO COMMENTS FROM RSA AND GG104 SAFETY RISK ASSESSMENT.
