National Highways has been notified regarding the below proposed Non-Material Change (NMC) application which seeks to make changes to the approved West Midlands Interchange Development Consent Order 2023 (amended). The proposed changes to the Order relate to consented finished carriageway levels on the A5 A449 link road.

National Highways has been engaged with applicant's planning consultant during the detailed design process and the proposed new carriageway levels are of relevance to National Highways. Whilst the A5/A449 Link Road is proposed for adoption by Staffordshire County Council, the roundabouts at either end are to be adopted by National Highways as the strategic highway authority. National Highways has reviewed these and is broadly content with this change.

National Highways welcomes further consultation as appropriate regarding any further proposed changes to the above consented Order.
