**Notice of Further Consultation**  
**Proposals for a rail freight interchange (including warehousing) on land to the west of Junction 15 of the M1 motorway (known as Northampton Gateway SRFI) and associated highway works.**  
 The purpose of this notice is to draw attention to some minor changes to the proposals for Northampton Gateway SRFI.  
 The proposals have previously been the subject of a non-statutory consultation carried out during December 2016 and January 2017 (called the Stage 1 Consultation) and a statutory consultation carried pursuant to section 42 of the Planning Act 2008 (the Act) during October - November 2017 (called the Stage 2 Consultation).

**THE NORTHAMPTONSHIRE COUNTY COUNCIL (ADNITT ROAD, NORTHAMPTON)**  
**(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2018**  
**NOTICE IS HEREBY GIVEN** that Northamptonshire County Council intend, not less than seven days from the date of this Notice, to make an Order the effect of which will be to prohibit traffic from proceeding along that length of Adnitt Road, Northampton as set out below.  
**LENGTH OF ROAD TO WHICH RESTRICTION APPLIES:** That length of Adnitt Road, Northampton from Stimpson Avenue to Bostock Avenue.  
**REASONS FOR RESTRICTION:** The restriction is required for safety during carriageway repairs and associated works.  
**PERIOD OF CLOSURE:** The proposed Order will come into effect on 15<sup>th</sup> January 2018 and will continue in force for a period of eighteen months.
