Technical Note 13 (Appendix 3 to the Applicant's updated Cumulative Impact Assessment with Rail Central (Doc 8.13 [AS-040])) includes Figures 1 and 2 taken from Rail Central's traffic modelling work. These are not particularly clear. It would assist the ExA's understanding of the Applicant's position regarding cumulative impacts on road junctions and areas of concerns if clearer plans with labelled junctions, descriptions and road numbers could be provided. It is requested that these be provided in advance of ISH4.
