Rail Central in their Deadline 5 submissions indicated that an update would be provided to the ExA in respect of Northampton Gateway's Technical Note "Rail Central Footpath Interface" prior to ISH4.

Rail Central is considering the request to amend RC Order Limits together with further technical detail provided by Northampton Gateway.

Rail Central has proposed that a technical meeting is arranged between both sets of experts to discuss Northampton Gateway's concerns regarding the Rail Central proposals as within paragraph 4.4 of the Technical Note and discuss how Northampton Gateway considers Footpath Connection B to be a workable solution.
