Members,

Wootton Parish Councillor, Sohrab Ghavami has contacted me in relation to the proposed amendment to the planning permission for the Northampton Rail freight interchange. The warehouse and logistics park that is being built on J15 of the M1 was approved as a strategic rail freight interchange, which means it needs to connect with mainline rail in order to receive and distribute freight. This was a condition of the planning application.

However, the development company, SEGRO, has applied for an amendment to the Development Consent Order (DCO) seeking permission for occupation of some of the warehousing ahead of the rail terminal being operational.
