Thank you for consulting Northamptonshire Police and Fire and Rescue Services on the above application for a non-material amendment to the above DCO.

My role is to comment on planning matters which impact on resources and response times relating to the above emergency services and seek developer contributions where appropriate.

Having viewed the submitted documents, I wish to make the following **representation** in respect of this proposal;

The supporting information does not provide information regarding the impact on traffic level changes arising from the proposed amendment. Northamptonshire Police and Northamptonshire Fire and Rescue (the Joint Service) are concerned that the amendment could give rise to addition highway movements resulting in congestion and an increase in road traffic accidents.

The Joint Service is keen to ensure that the local or national highway bodies are satisfied that this amendment will not adversely impact on traffic levels. If this is the case, no formal objection is raised.

If the aforementioned highway bodies, identify that this will impact on the highway network, this could have an adverse impact on highway safety and response times, resulting in delays for the Joint Service. We would expect this to be addressed and mitigation agreed, if this is predicted.
