(B4668 LEICESTER ROAD, HINCKLEY) (IMPOSITION OF 30 MPH, 40 MPH AND 50 MPH SPEED LIMITS) ORDER 2008

The Leicestershire County Council ("the Council") in exercise of its powers under Section 82 (2) and 83 (2) and Section 84 (1) and (2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- No person shall drive any motor vehicle at a speed exceeding 30 MPH on the length of road specified in Schedule 1 to this Order.
- No person shall drive any motor vehicle at a speed exceeding 40 MPH on the lengths of roads specified in Schedule 2 to this Order.
- No person shall drive any motor vehicle at a speed exceeding 50 MPH on the lengths of roads specified in Schedule 3 to this Order.
- This Order may be cited as "The Leicestershire County Council (B4668
 Leicester Road, Hinckley) (Imposition of 30 MPH, 40 MPH and 50 MPH Speed
 Limits) Order 2008" and shall come into force on the Thirteenth day of October
 2008.
- The plan annexed to this Order and marked drawing number 3266.00/Z1/1/1 is for identification purposes only.

SCHEDULE 1

IMPOSITION OF 30 MPH SPEED LIMIT

B4668 Leicester Road (Layby), Hinckley

For its entire length, a distance of approximately 108 metres.

Burbage Common Road, Hinckley

From its junction with B4668 Leicester Road layby for a distance of approximately 152 metres in a south easterly direction.

SCHEDULE 2

IMPOSITION OF 40 MPH SPEED LIMIT

B4668 Leicester Road, Hinckley

From a point approximately 17 metres east of its junction with the access of Fairways Court in a south westerly direction to a point 188 metres north east of its junction with Stoneygate Drive (location of existing 30 MPH Speed Limit) for a distance of approximately 624 metres.

SCHEDULE 3

IMPOSITION OF 50 MPH SPEED LIMIT

B4668 Leicester Road, Hinckley

From a point 7 metres south west of the southern boundary of the property Penryl in a south westerly direction to a point approximately 17 metres east of its junction with the access to Fairways Court for a distance of approximately 950 metres.
