Written submission about how the application should be examined

The Council has a comment on the Draft Examination Timetable, Annex E of the Rule 6 Letter:

The timetable does not specifically set out any deadline for the submission of draft Section 106 agreements. Given that mitigation will be secured through both the DCO and obligations in the S106, the Council asks whether the Examining Authority will want to examine the draft obligations during the examination and if so, when they will request this information. The Council expects to request further and amended obligations to that set out in Applicant's initial Heads of Terms (document ref. 10.1) and that these may evolve during the course of the Examination. Further details of this will be provided in our Written Representation. The Council considered that the S106 Heads of Terms could be examined in a similar way to the dDCO or Statements of Common Ground, with the Examining Authority reviewing them iteratively throughout the process.
