#### 1. INTRODUCTION

#### Purpose of the statement

- 1.1 This statement updates the Examining Authority (ExA) on the current status of Statements of Common Ground (SoCG) at deadline 2–3 (24 October 14 November 2023).
- 1.2 This statement has been prepared in response to a request by the ExA to set out the commonality on specific points between the SoCG agreed between the Applicant and the various bodies where SoCGs have been requested.
- 1.3 It is the intention that as further agreement and commonality through the SoCGs is reached, this document will be updated to reflect the latest position accurately.
- 1.4 For more detailed information on the respective stakeholders' positions, in relation to the topics covered in this statement, please refer to the specific SoCGs (document references 19.1 to 19.11).

#### Structure of the statement

- 1.5 This statement is structured as follows:
  - Section 2 and Appendix A-provides an up to date list of the SoCGs under preparation and the status of these SoCGs; and
  - Section 3 and Appendix B sets out the commonality between the SoCGs at deadline 23.

#### **Background to the SoCGs**

- 1.6 To ensure consistency across the SoCGs, a uniform approach has been taken to drafting. Each is generally structured as follows:
  - a) Tables setting out the matters agreed between the Applicant and the stakeholder on each topic;
  - Tables setting out the matters not agreed between the Applicant and the stakeholder on each topic, these tables include a traffic light rating system setting out both parties estimation as to the likelihood that disagreement will remain by the end of the examination (Low green, medium amber, high red); and

- c) Where relevant additional appendices are provided to support the discussions on the SoCG and information on the engagement undertaken.
- 1.7 The exception to this approach has been the SoCG prepared with Network Rail, where the approach taken has been led by the preferences of Network Rail.

#### 2. STATEMENTS OF COMMON GROUND UPDATE

- 2.1 The Applicant's submission contained an intent schedule, setting out those organisations and matters which the Applicant proposed to enter into a SoCG on (document reference 15.1, APP-356). The ExA in their Rule 6 letter issued on 11 August 2023 requested that SoCGs were prepared between the Applicant and the following parties:
  - Blaby District Council;
  - Hinckley and Bosworth Borough Council;
  - Leicestershire County Council;
  - Rugby Borough Council;
  - Harborough District Council;
  - Warwickshire County Council;
  - National Highways;
  - Network Rail;
  - Environment Agency;
  - Natural England; and,
  - Historic England.
- 2.2 The Applicant has prepared SoCGs with the above listed parties throughout the preexamination phase of the DCO and continuing during the early stages of the examination. These are based upon discussions which commenced prior to the DCO application submission.
- The table overleaf contains the full list of SoCG<sub>S</sub> and explains their current status. It also identifies any outstanding issues which are the subject of ongoing discussions and may therefore be the subject of further submissions in due course.

- 2.4 It should be noted that on <a href="13">13 October</a>7 November 2023, the Applicant set a deadline of <a href="17">17 October</a>10 November 2023 for Councils to provide responses to any SoCGs currently in their possession. The purpose of this deadline was to give the Applicant sufficient time to review and submit an updated SoCG to the Council prior to deadline <a href="32">32</a>. No <a href="15">SoCGs were returned after this date (and before deadline 3), but some remain with the relevant Councils.
- 2.5 Several SoCGs were returned to the Applicant after 17 October 2023. While the Applicant has endeavoured to review and submit an updated SoCG to the Council (also for inclusion in the deadline 2 submission) this has not been possible in all instances. Where this is the case, either the previous version submitted by the Applicant to the Council, or the latest version returned by the Council, has been included for the purposes of the deadline 2 submission. Some SoCGs were returned by the relevant Councils before the deadline and have not yet been responded to by the Applicant. This is generally the case where there has been a substantial change in position from the relevant Councils since the previous version. A summary of these notable instances are provided below:

#### • V6 Acoustics with BDC:

- Matter agreed 2: amendments to the wording for Requirement 26 of the draft DCO relating to control and operation of noise;
- Matter agreed 3: amendments to on the wording for Requirement 27 of the draft DCO relating to acoustic barriers;
- Matter agreed 18: removal of matter relating to operational phase assessment of maximum noise levels with mitigation in its entirety;
- Matter not agreed 4: where there is dispute relating to the assessment methodology applied;
- Matter not agreed 8: where there is a request for elevation drawings so that
   the wider impacts of a proposed 6m high barrier (for mitigation of off-site road impacts) can be appropriately assessed; and
- Matter not agreed 9: suggestion that the Applicant has overestimated the
   attenuation provided by the bunds and therefore underestimated the
   predicted impacts on sensitive receptors.

#### V6 Ecology with BDC:

- Matter agreed 2a: amendments to Requirement 21 of the draft DCO relating to the Ecological Mitigation Management Plan;
- Matter agreed 54: removal of matter relating to potential impacts from light pollution in its entirety;

- Matter agreed 55: amendments to Requirement 31 of the draft DCO relating to lighting;
- Matter agreed 59: removal of matter relating to air quality modelling in its entirety;
- Matter agreed 60: removal of matter relating to impacts on ecological receptors from changes to air quality in its entirety;
- Matter agreed 61: removal of matter relating to the adequacy of mitigation measures within the CEMP to avoid adverse impacts from dust in its entirety;
- Matter agreed 62: amendments to Requirement 7 of the draft DCO; and
- Additional matter not agreed: relating to concerns regarding the impact from nitrogen deposition on Free Holt Ancient Woodland.

#### V4 Climate with LCC:

- Matter agreed 1: removal of text referring to the proposal supporting
   sustainable development through encouraging a modal shift, helping to reduce traffic congestion and contribute towards improving air quality;
- Matter agreed 2: removal of text referring to the development being designed to meet a number of specific points in National Planning Policy Statement (NPPS);
- Matter agreed 3: removal of two bullet points relating to the acceptance of the assessment methodology for likely effects on climate change and recommendations to mitigate likely significance effects to "matter not agreed 3";
- Matter agreed 4: removal of matter relating to the sufficiency of the
   assessment to estimate the effects on greenhouse gas emission sources in
   its entirety to "matter not agreed 4";
- Matter not agreed 2: additions of text which provide suggestions for adaptations to provide resilience to climate change, and recommendation to consider ground source heat pump installation.

#### 2.5

- 2.6 There is an early draft SoCG in circulation between Network Rail and the Applicant.

  Network Rail and the Applicant have been working together closely for some years.

  Network Rail is on record as being supportive of the scheme.
- 2.7 Resources have in part been concentrated on settling the agreements which will be reflected in the SoCG, including dealing with Protective Provisions and other Representations. These are at an advanced stage.

- 2.6 However, it has not been possible to properly reflect these yet in the SoCG, as resources have had to be concentrated on addressing the ExA's evidence base requested for Narborough Level Crossing times. This is based on the current situation over 24 hours over 7 days, rather than the peak hour and shoulder hours of a typical working day, provided previously by agreement with Transport Working Group.
- 2.82.7 The Applicant has submitted a summary rail report (document reference 18.6.5) at deadline 3 which addresses matters in relation to Network Rail. The Applicant intends for this to be appended to the Network Rail SoCG to be submitted at deadline 4.
- 2.9 With regards to the SoCG with National Highways, a Highways Position Statement has been submitted and is the basis of a SoCG on transport matters.
- 2.102.8 For the sake of brevity, some topics have been excluded from the Council SoCGs where it has been agreed that one Council's position aligns with, or is incorporated into, another Council's SoCG. These instances are summarised as follows:
  - Socio-economics: where the LCC position aligns with the SoCG with BDC;
  - Acoustics: where the HBBC position is incorporated into the SoCG with BDC;
  - Heritage: where the LCC position is incorporated into the SoCG with BDC;
  - Ecology: where the LCC position relies on land use consultants through BDC and HBBC;
  - Landscape: where the LCC position relies on land use consultants through BDC and HBBC:
  - Geology, soils and groundwater: where the BDC position relies on the Environment Agency position; and
  - PRoW: where the BDC and HBBC position relies on the LCC position (as part of the Highways SoCG).
- 2.112.9 Other topics have been excluded where they are not relevant to a stakeholder.
