1. INTRODUCTION

Purpose of the statement

- 1.1 This statement updates the Examining Authority (ExA) on the current status of Statements of Common Ground (SoCG) at deadline 7 (27 February 2024).
- 1.2 This statement has been prepared in response to a request by the ExA to set out the commonality on specific points between the SoCG agreed between the Applicant and the various bodies where SoCGs have been requested.
- 1.3 It is the intention that as further agreement and commonality through the SoCGs is reached, this document will be updated to reflect the latest position accurately.
- 1.4 For more detailed information on the respective stakeholders' positions, in relation to the topics covered in this statement, please refer to the specific SoCGs (document references 19.1 to 19.11).

Structure of the statement

- 1.5 This statement is structured as follows:
 - Section 2 provides an up to date list of the SoCGs under preparation and the status of these SoCGs; and
 - Section 3 sets out the commonality between the SoCGs at deadline 7.

Background to the SoCGs

- 1.6 To ensure consistency across the SoCGs, a uniform approach has been taken to drafting. Each is generally structured as follows:
 - a) Tables setting out the matters agreed between the Applicant and the stakeholder on each topic;
 - b) Tables setting out the matters not agreed between the Applicant and the stakeholder on each topic, these tables include a traffic light rating system setting out both parties estimation as to the likelihood that disagreement will remain by the end of the examination (low – green, medium – amber, high – red); and
 - c) Where relevant additional appendices are provided to support the discussions on the SoCG and information on the engagement undertaken.
- 1.7 The exception to this approach has been the SoCG prepared with Network Rail, where the approach taken has been led by the preferences of Network Rail.

2. STATEMENTS OF COMMON GROUND UPDATE

- 2.1 The Applicant's submission contained an intent schedule, setting out those organisations and matters which the Applicant proposed to enter into a SoCG on (document reference 15.1, APP-356). The ExA in their Rule 6 letter issued on 11 August 2023 requested that SoCGs were prepared between the Applicant and the following parties:
 - Blaby District Council;
 - Hinckley and Bosworth Borough Council;
 - Leicestershire County Council;
 - Rugby Borough Council;
 - Harborough District Council;
 - Warwickshire County Council;
 - National Highways;
 - Network Rail;
 - Environment Agency;
 - Natural England; and
 - Historic England.
- 2.2 The Applicant has prepared SoCGs with the above listed parties throughout the preexamination phase of the DCO and continuing during the early stages of the examination. These are based upon discussions which commenced prior to the DCO application submission.
- 2.3 The table overleaf contains the full list of SoCGs and explains their current status. It also identifies any outstanding issues.
- 2.4 It should be noted that while deadline 7 constitutes the final submission of SoCGs to the ExA, information relating to highways are still being reviewed by National Highways, Leicestershire County Council and Warwickshire County Council. Therefore, some matters in these SoCGs which are currently not agreed may become agreed after the deadline.
- 2.5 For the sake of brevity, some topics have been excluded from the Council SoCGs where it has been agreed that one Council's position aligns with, or is incorporated into,

another Council's SoCG. These instances are summarised as follows:

- Heritage: where the LCC position is incorporated into the SoCG with BDC;
- Ecology: where the LCC position relies on land use consultants through BDC and HBBC;
- Landscape: where the LCC position relies on land use consultants through BDC and HBBC;
- Geology, soils and groundwater: where the BDC position relies on the Environment Agency position; and
- PRoW: where the BDC and HBBC position relies on the LCC position (as part of the Highways SoCG).
- 2.6 Other topics have been excluded where they are not relevant to a stakeholder.

3. COMMONALITY
