

Augean is currently preparing an application for a Development Consent Order (DCO) for an extension in the area and life of the East Northants Resource Management Facility (ENRMF).

The proposals at ENRMF are classified as a Nationally Significant Infrastructure Project (NSIP) under the Planning Act 2008 and consent must be granted by the Secretary of State in the form of a DCO.

Augean has been undertaking a formal pre-application statutory consultation for the project as required by Section 42 and Section 47 of the Planning Act 2008 since the end of October.

The company recognises the importance of giving the local community the opportunity to engage and help inform the proposed development before the application for a DCO is finalised and submitted to the Planning Inspectorate.

We understand that some people in the local community feel that they have had other concerns of greater priority and need extra time to consider the application documents and their responses to the consultation. Although the formal consultation deadline is Monday 14 December 2020, Augean will take account of any further responses received before Friday 8 January 2021.

So that members of the public can participate in the consultation, Augean has made an exhibition available online which is available [here](#). Further information about the application, including the Preliminary Environmental Information Report and supporting documentation, can be found on the Augean website [here](#).

If anyone is unable to access the exhibition online, they can ring the Telephone Helpline 01904 654989 to request a hard copy exhibition pack which contains a booklet version of the exhibition together with the Non-Technical Summary and all the response forms.


Copies of the consultation documents may be inspected free of charge using the online facilities only at Stamford Public Library and Oundle Public Library. Please check the opening times as these are subject to change due to the current circumstances.

An analysis of the responses we receive will be included in a Consultation Report that will accompany the application for the DCO. We will report back to the local community to let you know how we have responded to the comments we have received during the consultation process when we submit the application.

UPDATE from AUGEAN plc : 12th January 2021

ENRMF Consultation Extended

Augean has been consulting about its proposals to extend the operational area of the East Northants Resource Management Facility (ENRMF) since the end of October. The company fully recognises the importance of giving the local community the opportunity to help inform the proposed development before the application for a Development Consent Order (DCO) is finalised and submitted to the Planning Inspectorate and has allowed a ten week consultation period so far; the company is now extending the consultation period further to mid -February.

Augean has explained to members of the local community that have made enquiries regarding the end of the formal consultation on 8 January 2021 that it is happy to consider any submissions that are made after this date and indeed throughout the entire DCO application process. However, it has been suggested to us that it would be helpful for Augean to formalise this arrangement which it is happy to do.

The consultation is therefore extended once more with a deadline of responses of Monday 15 February 2021.

The DCO application process allows for several stages of consultation with the local community and that the current formal consultation period is only the first stage of the wider consultation process. There will be several other opportunities to provide comment both to Augean and directly to the Secretary of State through the Planning Inspectorate in the coming months once the application has been submitted.

As soon as Covid-19 restrictions are lifted sufficiently and Augean is safely able to, it will be able to recommence our programme of Open Days that are annually as well as offering visits to the site by arrangement as part of the Open Door policy to provide additional opportunities for the local community to discuss the application and make further comments. These will be publicised nearer the time.

So that members of the public can participate in the consultation Augean has made the public exhibition available online at www.augeanconsultation.co.uk.

The exhibition includes opportunities to send in questions about the proposed development which the Augean professional team will be pleased to answer and an online comments sheet so that responses to the consultation can be submitted. There are links to all the consultation documents that explain the proposals in detail.

A decision is not due any time soon, and there are many more stages of consultation, impact and risk assessments, studies and discussions to be gone through over the next year or two.

Extension to hazardous waste site

The existing site near to Fineshade Wood is known as the **East Northants Resource Management Facility (ENRMF)**. It is operated by **Augean PLC** and in 2019 they issued the following press release:

Augean, one of the UK's leading specialist waste management businesses, has acquired an option to purchase approximately 90 acres of land adjacent to its existing East Northants Resource Management Facility landfill site near Peterborough. This option is Augean's preferred choice following their investigation of a number of alternative solutions to provide long term key infrastructure, aligning with the national need for hazardous landfill and soil treatment in the South of England. With appropriate planning and permitting consent, the extension that has been optioned would prolong the life of the ENRMF site until the mid-2040s. ENRMF currently generates revenue of over £15m per annum and operating profit of over £8m.

However, the proposed site would sever the fragile connection between two important species-rich woods. There is an alternative location which would not have the same dire effects in biodiversity... read on!

In an email to Councillor Annabel de Capell Brooke on January 8th Augean made it clear that they will continue to accept and consider late submissions to the consultation.

The 20-page **Non-Technical Summary** includes maps. The full report, the **Preliminary Environmental Information Report or PEIR**, runs to 218 pages, plus extra appendices and figures.

There is also an online poster exhibition (which seems to take ages to download)

This stage of the consultation is "pre-application". You will be asking Augean to change their mind, or change the details or carry out more surveys. They are legally bound to record what you've said and to present your comments if they decide to go ahead with the plan as it stands at the moment.

If that happens the Planning Inspectorate will run their own consultation and you'll get your chance to submit your comments again.

Here's some pictures of the Augean landfill site where radioactive and hazardous waste is being buried. It's currently 300yards away from the top edge of Fineshade Wood and work there should end in 6 year's time. But Augean are proposing to extend the site for another 20 years bringing their working area right to the edge of the wood.

And most importantly their proposals would effectively separate the wildlife-rich Fineshade woodland from the nearby National Nature Reserve. And this at a time when the government is telling us how important it is to plant more trees and connect the remaining fragments of woodland!
