A summary of the final position regarding the documentation that had not been finally agreed as at Deadline 7 (20 July 2022)

As indicated in the Statement of Commonality v5 submitted at Deadline 7 (REP7-009), there were a few documents which had not reached final agreement at that time. The current status of those documents is summarised below.

Statement of Common Ground with Western Power Distribution Limited

The latest version remains that as submitted at Appendix E to the Statement of Commonality v5 (REP7-009) submitted at Deadline 7.

Statement of Common Ground with Anglian Water

A signed agreed version of the Statement of Common Ground is provided at Appendix K to the Statement of Commonality v6 (PINS document reference 9.3) submitted at Deadline 8.
