## PLANNING ACT 2008 – PROPOSED THAMES WATER UTILITIES LIMITED (THAMES TIDEWAY TUNNEL) DEVELOPMENT CONSENT ORDER

## APPLICATIONS FOR A CERTIFICATE UNDER SECTION 127(2): LAND IN THE OWNERSHIP OF THE ENVIRONMENT AGENCY

- 1. I refer to the above applications made to the Secretary of State for Environment, Food and Rural Affairs ("SoS/Defra") by Thames Water Utilities Limited ("the Applicant") on 6 November 2013 in relation to land held by the Environment Agency ("the Agency"), and to the report submitted on 12 June 2014 by the Panel which examined those applications on behalf of the SoS/Defra.
- 2. The need for a certificate under section 127 of the Planning Act 2008 arises because the Agency has property interests at Barn Elms, Richmond upon Thames, where surface land is needed for construction works, and at Beverley Brook, Wandsworth, where subsoil is needed for the construction of the connection tunnel from Barn Elms to the River Thames. The Agency submitted a representation to the Panel which was not withdrawn.
- 3. In its report, the Panel noted that there was no issue between the parties that the land in question was operational land, and that the Applicant was of the view that the land could be purchased and not replaced without serious detriment to the carrying on of the undertaking. The Panel also noted that the Agency did not disagree with this view and had agreed that the deep subsoil could be acquired using compulsory acquisition powers.

- 4. Having considered the evidence before it, the Panel is satisfied that the operational land and interests required by the Applicant can be taken without serious detriment to the carrying on of the undertaking, and accordingly recommended at paragraph 24 of its report that the SoS/Defra should give the certificate under section 127(2) of the Planning Act 2008.
- 5. The SoS/Defra agrees with the Panel that in the circumstances described above he is required to decide whether to give the certificate applied for and has therefore considered the Panel's conclusions and recommendation on these applications. She agrees with the Panel that the operational land and interests of the Agency required by the Applicant can be taken without serious detriment to the carrying on of the Agency's undertaking.
- 6. I accordingly enclose with this letter a certificate given under section 127(2) of the Planning Act 2008 and a draft notice for the purposes of section 127(7) of the Planning Act 2008.
