

## NOTICE OF SECRETARY OF STATE'S CERTIFICATE UNDER SECTIONS 131(10) and 132(10) OF THE PLANNING ACT 2008

## DRAFT THAMES WATER UTILITIES LIMITED (THAMES TIDEWAY TUNNEL) DEVELOPMENT CONSENT ORDER 2013 (PINS Ref:) WW010001

The above application, which has been submitted to the Secretary of State for Communities and Local Government and the Secretary of State for Environment, Food and Rural Affairs by Thames Water Utilities Limited seeks an order granting development consent which authorises the compulsory acquisition of land and rights over land forming part of an open space. The land and rights are described in the Schedules 1 and 2 to this notice respectively.

Such an order must be subject to special parliamentary procedure unless the Secretary of State issues a certificate in accordance with section 131(3)(b) and section 132(2)(b) of the Planning Act 2008 ("the Act").

The Secretary of State for Communities and Local Government in exercise of powers under section 131(3)(b) of the Act, has certified that the Secretary of State is satisfied that: the order land is, or forms part of, an open space; none of the order land forms part of a common or a fuel or field garden allotment; there is no suitable land available to be given in exchange for the order land; and it is strongly in the public interest for the development for which the order grants consent to be capable of being begun sooner than is likely to be possible if the order were to be subject (to any extent) to special parliamentary procedure.

The Secretary of State for Communities and Local Government in exercise of powers under section 132(2)(b) of the Act, has certified that the Secretary of State is satisfied that the order land, when burdened with the order right, will be no less advantageous than it was before to the persons in whom it is vested, other persons, if any, entitled to rights of common or other rights, and the public.
